

AN ORDINANCE 9 8 2 6 9

APPROVING A PARADE PERMIT AND AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN STREETS NEAR FRANKLIN ELEMENTARY, LOCATED AT 1915 W. OLMOS, IN CONNECTION WITH THE FRANKLIN ELEMENTARY FALL COSTUME PARADE SPONSORED BY THE SCHOOL TO BE HELD ON FRIDAY, OCTOBER 31, 2003 FROM 1:00 P.M. UNTIL 2:30 P.M.

WHEREAS, the **BEN FRANKLIN ELEMENTARY** has applied for a parade permit to hold the Franklin Elementary Fall Costume Parade on Friday, October 31, 2003 beginning at 1:00 p.m. until 2:30 p.m.; and

WHEREAS, in order for this event to take place, it will be necessary to temporarily close portions of certain streets near Franklin Elementary located at 1915 W. Olmos to vehicular traffic, as stated in the route in "Section 2" below; and

WHEREAS, the City Council finds that granting the request will promote the health, safety and welfare of the participants and the public in the vicinity; and

WHEREAS, the request has been evaluated and it has been found that no adverse traffic problems would result, and that the request should be granted in accordance with the City's usual practice and procedure; **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council hereby approves the requested parade permit to Ben Franklin Elementary School so that it may hold the Franklin Elementary Fall Costume Parade on Friday, October 31, 2003 beginning at 1:00 p.m. until 2:30 p.m.

SECTION 2. In order to hold Franklin Elementary Fall Costume Parade on Friday, October 31, 2003 beginning at 1:00 p.m. until 2:30 p.m., the temporary closure of portions of the streets listed in the route below to vehicular traffic is hereby authorized:

Assembly Area: Ben Franklin Elementary School (1935 W. Olmos back of school Fresno side)

Route:

WEST ON FRESNO FROM BACK SIDE OF SCHOOL TO ANGELES
SOUTH ON ANGELES FROM FRESNO TO SACRAMENTO
EAST ON SACRAMENTO FROM ANGELES TO EXCELSIOR
NORTH ON EXCELSIOR FROM SACRAMENTO TO OLMOS
EAST ON OLMOS FROM EXCELSIOR TO SCHOOL
PARKING LOT AND DISBAND

SECTION 3. The City Manager is authorized to further implement this ordinance by taking any additional actions deemed necessary to protect the public.

SECTION 4. BEN FRANKLIN ELEMENTARY SCHOOL shall be responsible for the following:

- a) all insurance requirements,
- b) paying the required street closure permit fee and any other fees and license charges,
- c) posting signs, barricades and the use of any off duty or on-duty police officers, as may be required by the City of San Antonio's Public Works and/or Police Departments, to evidence the street closure and to provide for the safety of patrons and the rerouting of traffic, and
- d) cleaning the area up after the event is held.

SECTION 5. BEN FRANKLIN ELEMENTARY SCHOOL shall assume all risks inherent in this event and shall indemnify and hold harmless the City of San Antonio from any and all costs, damages, injuries, or losses attendant to, or in any way growing out of this special use of the public street right-of-ways.

SECTION 6. This ordinance shall be effective on the 12th day of October, 2003.


