

AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF A CHANGE TO CONTRACT #7460020708C 2004 WITH THE TEXAS DEPARTMENT OF HEALTH (TDH) TO PROVIDE \$34,500.00 TO THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT IN SUPPORT OF THE ONGOING MILK AND DAIRY LABORATORY SAMPLE TESTING PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT FOR THE PERIOD SEPTEMBER 1, 2003 THROUGH AUGUST 31, 2004; AUTHORIZING THE EXECUTION OF A CHANGE TO THE CONTRACT; ADOPTING THE PROGRAM BUDGET; AND AUTHORIZING PAYMENTS FOR CONTRACTUAL SERVICES.

WHEREAS, the Texas Department of Health (TDH) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

WHEREAS, these services include a variety of activities, including the testing of milk samples from local retailers; and

WHEREAS, Ordinance 98265, passed and approved on October 2, 2003, authorized the execution of Contract 7460020708C 2004 between the City of San Antonio and TDH covering operation of the Public Health State Support Project 2003/2004 in the SAMHD; and

WHEREAS, TDH has now offered funding in the amount of \$34,500.00 through Contract Change Notice No. 02, Attachment 03, to the above contract for the period September 1, 2003 through August 31, 2004 to renew support for the ongoing Milk and Dairy Laboratory Sample Testing Program of the SAMHD; and

WHEREAS, it is now necessary to authorize the acceptance and execution of the contract change, adopt the program budget, and authorize payments for contractual services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is authorized to accept Contract Change Notice No. 02, Attachment 03 of TDH Contract No. 7460020708C 2004 granting \$34,500.00 in contract support for the period September 1, 2003 through August 31, 2004, to be used in connection with the ongoing Milk and Dairy Laboratory Sample Testing Program in the SAMHD. The City

Manager, or her designee, is authorized to execute Contract Change Notice No. 02, Attachment 03, and a copy is set out as Attachment II and incorporated herein for all purposes.

SECTION 2. Fund No. 26-016062 entitled "Public Health State Support Project 2003-2004 (State)" is hereby designated for use in accounting for the fiscal transactions of this project. This fund is authorized to be revised in accordance with Contract Change Notice No. 02.

SECTION 3. The sum of \$34,500.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

SECTION 4. The aggregate sum not to exceed \$34,500.00 is authorized for payment from Fund No. 26-016062, Activity 36-10-34, Index Code 365890 to cover laboratory services for testing of milk samples from local retailers.


SECTION 5. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.



Should the contract change be in an amount other than that budgeted for, or should the contract change contain terms and conditions different than those currently existing, acceptance of the contract change, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

SECTION 7. This ordinance shall be effective on and after the tenth day after passage hereof.
