

AN ORDINANCE

AUTHORIZING THE EXPENDITURE OF \$250.00 FROM THE MAYOR'S CONTINGENCY ACCOUNT FUND, PAYABLE TO THE SAN ANTONIO CHAPTER OF HADASSAH TO SAVE A LIFE, TO BE USED TO OFFSET EXPENSES ASSOCIATED WITH EDUCATING COMMUNITIES, FAMILIES, AND INDIVIDUALS THROUGHOUT SAN ANTONIO REGARDING THE URGENCY OF ORGAN AND TISSUE DONATION; AS REQUESTED BY MAYOR EDWARD D. GARZA.

WHEREAS, Mayor Edward D. Garza has requested Council concurrence for the expenditure of \$250.00 from the Mayor's Contingency Fund to assist the San Antonio Chapter of Hadassah to Save a Life by offsetting expenses associated with educating communities, families and individuals throughout San Antonio regarding the urgency of organ and tissue donation; and

WHEREAS, the San Antonio Chapter of Hadassah To Save a Life advances the public purpose of promoting public health; and

WHEREAS, the City Council wishes to authorize the expenditure requested by Mayor Edward D. Garza; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Mayor Edward D. Garza, for reimbursement from the Mayor's Contingency Fund in the amount of \$250.00 to the San Antonio Chapter of Hadassah to Save a Life by offsetting expenses associated with educating communities, families and individuals throughout San Antonio regarding the urgency of organ and tissue donation is hereby approved and authorized. A copy of Mayor Edward D. Garza's request is set out in **Attachment I**.


SECTION 2. The City Manager, or her designee, is hereby authorized to execute an agreement with the San Antonio Chapter of Hadassah to Save a Life in the amount of \$250.00. A copy of the "Agreement to Use Funds of the City of San Antonio," in substantially final form, is attached hereto as **Attachment II**.

SECTION 3. The amount of \$250.00 is authorized to be encumbered for payment in the Mayor's Contingency Budget Account, Index Code 603696 entitled "Mayor Contingency Fund" and is made payable to the San Antonio Chapter of Haddassah To Save A Life.


SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall become effective on the tenth day after the passage hereof.
