

AN ORDINANCE

**AUTHORIZING THE EXPENDITURE OF \$500.00 FROM THE DISTRICT 3 CONTINGENCY ACCOUNT FUND, PAYABLE TO THE NATIONAL ALLIANCE FOR THE MENTALLY ILL, TO BE USED FOR A FAMILY EDUCATION CLASS TO EDUCATE FAMILY MEMBERS WHO HAVE A FAMILY MEMBER WHO IS MENTALLY ILL ABOUT COPING METHODS, COMMUNITY RESOURCES AVAILABLE AND ADVOCACY ON BEHALF OF THEIR MENTALLY ILL FAMILY MEMBER; AS REQUESTED BY COUNCILWOMAN ANTONIETTE “TONI” MOORHOUSE.**

**WHEREAS**, Councilwoman Antoniette “Toni” Moorhouse, District 3, has requested Council concurrence for the expenditure of \$500.00 from the District 3 Contingency Account Fund to the National Alliance for the Mentally Ill to be used for a Family Education Class to educate family members who have a family member who is mentally ill about coping methods, available community resources and advocacy on behalf of their mentally ill family member; and

**WHEREAS**, the National Alliance for the Mentally Ill promotes the public purpose of supporting the mentally ill community and their families; and

**WHEREAS**, the City Council wishes to authorize the expenditure requested by Councilwoman Antoniette “Toni” Moorhouse ; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The request of Councilwoman Antoniette “Toni” Moorhouse, District 3, for reimbursement from the District 3 Contingency Account Fund in the amount of \$500.00 to the National Alliance for the Mentally Ill to be used for a Family Education Class to educate family members who have a family member who is mentally ill about coping methods, available community resources and advocacy on behalf of their mentally ill family member is hereby approved and authorized. A copy of Councilwoman Antoniette “Toni” Moorhouse’s request is set out in **Attachment I.**


**SECTION 2.** The City Manager, or her designee, is hereby authorized to execute an agreement with the National Alliance for the Mentally Ill in the amount of \$500.00. A copy of the "Agreement to Use Funds of the City of San Antonio," in substantially final form, is attached hereto as **Attachment II**.

**SECTION 3.** The amount of \$500.00 is authorized to be encumbered for payment in the District 3 Contingency Account, Index Code 603506 entitled "District 3 Contingency Fund" and is made payable to the National Alliance for the Mentally Ill towards a family education class.


**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance shall become effective on the tenth day after the passage hereof.
