

AN ORDINANCE

97138

AUTHORIZING THE EXPENDITURE OF \$1,500.00 FROM THE DISTRICT 4 CONTINGENCY ACCOUNT FUND, PAYABLE TO THE PARK SOUTH VILLAGE COMMUNITY ASSOCIATION, TO BE USED TO OFFSET EXPENSES AND PURCHASE TROPHIES FOR THE ASSOCIATION'S SOFTBALL LEAGUE CLOSING CEREMONIES IN AUGUST 2003; AS REQUESTED BY COUNCILMAN ENRIQUE "KIKE" MARTIN.

WHEREAS, Councilman Enrique "Kike" Martin, District 4, has requested Council concurrence for the expenditure of \$1,500.00 from the Council District 4 Contingency Fund to be used for costs associated with children's softball trophies and closing ceremonies to be held in August 2003; and

WHEREAS, the City Council wishes to authorize the expenditure as requested by Councilman Enrique "Kike" Martin, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Councilman Enrique "Kike" Martin, District 4, for payment from the District 4 Contingency Budget Account in the total amount of \$1,500.00 to the Park South Village Community Association, for the purpose set out above is hereby approved and authorized. A copy of Councilman Martin's request is set out in Attachment I.

SECTION 2. The amount of \$1,500.00 is encumbered for payment in the District 4 Contingency Budget Account, Index Code 60355 entitled "District 4 Contingency Fund," and is made payable to the Park South Village Community Association.


SECTION 3. The City Manager, or her designee, is hereby authorized to execute an agreement with the Park South Village Community Association in the amount of \$1,500.00 for costs set out above. A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appearing in substantially the same form as Attachment II.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.
