

AN ORDINANCE **98402**

AUTHORIZING THE EXECUTION OF TWO CONTRACTS WITH THE SAN ANTONIO INDEPENDENT SCHOOL DISTRICT (SAISD) TO IMPLEMENT THE URBAN SMARTS PROGRAM ADMINISTERED BY THE DEPARTMENT OF COMMUNITY INITIATIVES' YOUTH SERVICES DIVISION, AT FOUR SAISD 21ST CENTURY ELEMENTARY SCHOOLS (CARVAJAL, RODRIGUEZ, RUIZ AND WASHINGTON) FROM SEPTEMBER 8, 2003 TO MAY 31, 2004 AND AT TWO RECONNECT MIDDLE SCHOOLS (COOPER AND DAVIS) FROM OCTOBER 28, 2003 TO JUNE 30, 2004 IN THE AMOUNTS OF \$50,000.00 AND \$13,780.00, RESPECTIVELY; AND APPROVING A BUDGET.

WHEREAS, the Urban smARTS Program has provided arts enrichment and early intervention services to elementary and middle school students since 1994 and has attempted to divert them from the juvenile justice system, improve social behavior and social skills, improve academic performance and commitment to school, develop art skills, provide opportunities for artistic performances and exhibitions, and provide an after-school safe haven; and

WHEREAS, the Urban smARTS Program served 488 students at seventeen elementary and middle schools in the San Antonio, Northside, North East and Edgewood Independent School Districts during FY 2002-2003 with funding from the San Antonio Independent School District (SAISD) and the City's General Fund; and

WHEREAS, a contract in the amount of \$50,000.00 with the SAISD will be used to pay for up to eight artists, eight art assistants and related program curriculum supplies at four SAISD elementary schools; and

WHEREAS, a second contract in the amount of \$13,780.00 with SAISD will be used to pay for up to four artists, four art assistants and related program curriculum supplies at two SAISD middle schools; and

WHEREAS, the Urban smARTS Program proposes to serve one hundred and eighty (180) students at six schools with funding from the SAISD during FY 2003-2004; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1: The City Manager, or her designee, or the Director of the Department of Community Initiatives is authorized to execute a contract with the San Antonio Independent School District (SAISD) in the amount of \$50,000.00 to implement the Urban smARTs Program at four 21st Century elementary schools (Carvajal, Rodriguez, Ruiz, and Washington Elementary Schools) from September 8, 2003 to May 31, 2004. The City Manager or her designee or the Director of Community Initiatives is further authorized to execute a contract with SAISD in the amount of \$13,780.00 to implement the Urban smARTS Program at two Reconnect Middle Schools (Cooper and Davis) from October 28, 2003 to June 30, 2004. Copies of both contracts are attached hereto and incorporated herein as Attachments I and II.

SECTION 2: Fund No. 26-012253 entitled: "Urban smARTS 04 – San Antonio Independent School District" is hereby designated for use in accounting for said program, and the sum of \$63,780.00 is hereby appropriated in said fund as set out in the budget, attached hereto and incorporated herein for all purposes as Attachment III.

SECTION 3: The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4: This ordinance shall be effective on the tenth (10th) day after passage hereof.
