

AN ORDINANCE

**AUTHORIZING 1994 G.O. DRAINAGE BOND FUNDS IN THE AMOUNT OF \$7,500.00 FOR THE RIGHT OF ENTRY TO 15 PRIVATELY OWNED PROPERTIES IN CONNECTION WITH THE W. W. WHITE PHASE I – RIGSBY TO LORD PROJECT, LOCATED IN COUNCIL DISTRICT 2; APPROPRIATING FUNDS FOR RIGHT OF ENTRY AGREEMENTS; REVISING THE PROJECT BUDGET; AND PROVIDING FOR PAYMENT.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The amount of \$7,500.00 is appropriated and authorized to be paid to 15 private property owners for rights of entry as part of the W.W. White Phase I – Rigsby to Lord Project.

**SECTION 2.** The properties are described in the attached **Exhibit A**.

**SECTION 3.** The budget in Fund No. 45-460095, 1994 Drainage Bonds – Sold in 2000, shall be revised by reducing Index Code 561258, entitled “Unallocated Appropriation-Proceeds”, by the amount of \$7,500.00.

**SECTION 4.** The amount of \$7,500.00 is appropriated in Fund No. 45-460003, 1994 Drainage Bonds – Sold in 2000, in Index Code 920173, entitled “Trf to 45-546007, WW White/Rigsby to Lor”. The amount of \$7,500.00 is authorized to be transferred from fund 45-460003 to Fund 45-546007.


**SECTION 5.** The budget in Fund No. 45-546000, 1985 Drainage & Flood Control, Sold 1994, shall be revised by increasing Index Code 129650, entitled “Trf Fm 45-460003(45-546007) WW White”, by the amount of \$7,500.00.

**SECTION 6.** The amount of \$7,500.00 is appropriated in Fund 45-546007, 1985 Drainage & Flood Control, Sold 1994, in index code 625384, entitled Right of Entry Fees, and is authorized to be encumbered and made payable for right of entry agreements, in connection with the W.W. White Phase I – Rigsby to Lord Project.

**SECTION 7.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocation to specific Index Codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 8.** This Ordinance shall be effective on the 23rd day November, 2003.
