

AN ORDINANCE **98746**

APPROVING FIELD ALTERATION NO. 2 AND AUTHORIZING PAYMENT FROM 1999 GENERAL OBLIGATION FLOOD CONTROL WITH PARK IMPROVEMENT BONDS IN THE AMOUNT OF \$56,500.00 TO YANTIS CORPORATION FOR CONSTRUCTION EXPENSES IN CONNECTION WITH THE CULEBRA ROAD/LOOP 410 (LEON CREEK) REGIONAL STORM WATER FACILITY PROJECT, LOCATED IN COUNCIL DISTRICT 6; REVISING THE PROJECT BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute City of San Antonio Field Alteration No. 2 in the amount of \$56,500.00 to the contract with **Yantis Corporation**. Said contract was approved on June 26, 2003 pursuant to Ordinance No. 97883 in connection with the Culebra Road/Loop 410 (Leon Creek) Regional Storm Water Facility Project. A copy of Field Alteration No. 2 is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. The following financial adjustments are hereby authorized to effect this Ordinance:

- a) The budget and encumbrance in Fund No. 45-959003, 1999 Flood Control with Park Improvements, Sold 1999, shall be revised by reducing Index Code 763037, "Construction Contingency", by the amount of \$56,500.00.
- b) The amount of \$56,500.00 is appropriated in Fund No. 45-959003, 1999 Flood Control with Park Improvements, Sold 1999, in Index Code 763029, entitled "Construction Contract", and is authorized to be encumbered and made payable to **Yantis Corporation** for construction in connection with the Culebra Road/Loop 410 (Leon Creek) Regional Storm Water Facility project.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


SECTION 4. This ordinance shall take effect on the 8th day of February 2004.


