

AN ORDINANCE

ACKNOWLEDGING A CONTRACT MODIFICATION FROM THE ALAMO WORKFORCE DEVELOPMENT, INC. (AWD), WHICH AWARDS WORKFORCE INVESTMENT ACT FUNDS IN THE AMOUNT OF \$200,000.00 FOR THE PERIOD OF SEPTEMBER 1, 2003 THROUGH AUGUST 31, 2004 IN CONNECTION WITH THE ALAMO AREA CHILD CARE DELIVERY SYSTEM (CCDS) PROGRAM; AUTHORIZING ACCEPTANCE OF SUCH ADDITIONAL FUNDS FROM AWD FOR THE PROVISION OF CHILD CARE SERVICES AND OPERATIONS IN CONNECTION THEREWITH; AND ADOPTING A REVISED CCDS PROGRAM BUDGET.

WHEREAS, on August 28, 2003, pursuant to Ordinance No. 98090, the City Council authorized the operation of the Alamo Child Care Delivery System (CCDS) program from September 1, 2003 to August 31, 2005 with funds from the Texas Workforce Commission (TWC) awarded and managed through Alamo Workforce Development Incorporated (AWD); and

WHEREAS, the City of San Antonio, through its Children's Resources Division of the Department of Community Initiatives serves as the administrator for the CCDS program for the Alamo Workforce Development Area; and

WHEREAS, AWD has issued a contract modification that provide Workforce Investment Act (WIA) funds in the amount of \$200,000.00 for direct child care expenses and operations for authorized services provided in connection with said program; and

WHEREAS, it is now necessary to acknowledge a contract modification from AWD in connection with said program, authorize the acceptance of Workforce Investment Act funds in connection therewith, and adopting a revised CCDS program budget, **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. A Unilateral Modification from the Alamo Workforce Development, Inc. (AWD), which awards \$200,000.00 in Workforce Investment Act funds for the period of September 1, 2003 through August 31, 2004 in connection with the Alamo Area Child Care Delivery System (CCDS) Program, is hereby acknowledged. A copy of the modification is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The City Manager, or her designee, are authorized to accept additional funds in the amount of \$200,000.00 for direct child care services and operations in connection with the Alamo CCDS Program for the period of September 1, 2003 through August 31, 2004.

SECTION 3. The revised budget for Project No. 26-039016 entitled "Child Care Delivery System 2003-2004", attached hereto and incorporated herein for all purposes as Attachment II, is hereby adopted.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, subject to concurrence by the City Manager or her designee, may correct the allocations to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.


SECTION 5. This ordinance shall be effective on February 8, 2004.


