

AN ORDINANCE **9 8 7 8 6**

AMENDING THE PROFESSIONAL SERVICES CONTRACT AND AUTHORIZING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS IN AN AMOUNT NOT TO EXCEED \$9,430.00 PAYABLE TO TWYLA ARTHUR FOR ADDITIONAL DESIGN SERVICES IN CONNECTION WITH THE FULTON STREET - BLANCO TO N. FLORES CDBG PROJECT, LOCATED IN COUNCIL DISTRICT 1; REVISING THE PROJECT BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.

WHEREAS, by Ordinance No. 89781, passed and approved on May 20, 1999, a professional services contract was awarded to Twyla Arthur for design services to be rendered in connection with the Fulton Street - Blanco to N. Flores Project as part of the Community Development Block Grant (CDBG) Program; and

WHEREAS, in connection with said Project, there exists a need to provide for additional design services for the preparation of fabrication and installation of design enhancements to include an additional 410 square feet of wall plus enhancements to aesthetically coordinate with the retaining wall design; and

WHEREAS, it is the City Council's intention to authorize a professional services contract with Twyla Arthur for performance of such services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The sum of \$9,430.00, representing costs for additional design services is hereby authorized to be paid to Twyla Arthur in connection with the Fulton Street - Blanco to N. Flores Community Development Block Grant (CDBG) Project. In this regard, the professional services contract with Twyla Arthur authorized in Ordinance No. 89781, passed and approved on May 20, 1999, is hereby authorized to be amended to reflect such services and costs therefor.

SECTION 2. The budget of Fund Nos. 26-013361, 26-013364 and 28-026021 are hereby authorized to be revised in accordance with the budget schedule affixed hereto and incorporated herein for all purposes as Attachment I.

SECTION 3. The amount of \$9,430.00 is hereby authorized for payment and encumbrance to Twyla Arthur from Fund No. 26-013364, Index Code No. 326140.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective on the 15th day of February, 2004.
