

AN ORDINANCE **99034**

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION IN THE AMOUNT OF \$790,920.00 TO THE TEXAS DEPARTMENT OF HUMAN SERVICES FOR THE 2004 SUMMER FOOD SERVICE PROGRAM OPERATED BY THE DEPARTMENT OF PARKS AND RECREATION; AUTHORIZING THE ACCEPTANCE OF THE GRANT, IF AWARDED; APPROPRIATING FUNDS; APPROVING A BUDGET AND PERSONNEL COMPLEMENT; AUTHORIZING THE TRANSFER OF FUND BALANCES FROM THE 2003 SUMMER FOOD SERVICE PROGRAM BUDGET; AND AUTHORIZING THE ACCEPTANCE OF ADDITIONAL FOOD SUPPORT, IF AWARDED, DURING THE TERM OF THIS PROJECT.

WHEREAS, the City of San Antonio, through the Department of Parks and Recreation, has provided a Summer Food Service Program for the residents of San Antonio and Bexar County since 1969; and

WHEREAS, said program provides nutritional meals during the summer months to children age eighteen and below who would not otherwise have available the food assistance they receive during the school year through the National School Lunch and Breakfast Program; and

WHEREAS, the Department of Parks and Recreation operates this Summer Food Service Program in conjunction with the Summer Recreation Program; and

WHEREAS, it is now necessary to authorize the submission of an application for the Summer Food Service Program for 2004, establish a fund, approve a budget and personnel complement, and to authorize the acceptance of any additional food support funds received during the term of this grant; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to submit an application to the Texas Department of Human Services for \$790,920.00 in funding for the 2004 Summer Food Service Program operated by the Department of Parks and Recreation.

SECTION 2. The City Manager or her designee is hereby authorized to accept the 2004 Summer Food Service Program grant when awarded and to execute such documents as the granting agency shall require in connection with this grant after review and approval by the City Attorney.

SECTION 3. The Summer Food Service Project 2004, Fund No. 26-017105 is hereby designated for use in accounting for the above project upon award of the TDHS grant.

SECTION 4. Subject to the award of the TDHS grant, the sum of \$790,920.00 is appropriated into Fund No. 26-017105 for the Summer Food Service Project 2004 and the budget set out in Attachment I is approved and adopted for entry on the City's books.

SECTION 5. When ascertained, the remaining cash balance in Fund No. 26-017104, Summer Food Service Program 2003 is authorized to be transferred into Fund No. 26-017105, Index Code 106039, entitled Transfer from 26-017104.


SECTION 6. The budget of the Summer Food Service Project 2004, Fund No. 26-017105 is hereby authorized to be revised to reflect any additional food support funds received from THDS during the term of this project.


SECTION 7. The financial allocations in this Ordinance are subject to approval by the Director of Finance of the City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.


SECTION 8. The seventeen (17) personnel positions set out in Attachment I and incorporated herein, are authorized for the Summer Food Service Project 2004.

SECTION 9. This ordinance shall be effective on April 18, 2004.
