

AN ORDINANCE **99787**

ESTABLISHING A \$1.00 PRESERVATION FEE TO BE CHARGED PER
CARVER EVENT TICKET ITEM THAT WILL BE UTILIZED AS A
RENEWAL AND REPLACEMENT FUND.

WHEREAS, the Carver Community Cultural Center (Center), a City facility and a special project of the Department of Community Initiatives, is a leading multicultural arts presenter and educational institution serving the San Antonio metropolitan areas; and

WHEREAS, it is important to maintain the high quality of visual and performing arts events presented by the Center by maintaining the Center facilities in a proper manner; and

WHEREAS, the Center facilities experience normal wear and tear maintenance expenses through use of the facilities and management of the Center desires to establish a fee that will offset some of the costs of maintaining the facility in a proper manner; and

WHEREAS, it is now necessary to authorize the establishment and collection of a Carver Community Cultural Center Preservation Fee in the amount of \$1.00 per event ticket; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The establishment and collection of a Carver Community Cultural Center (Center) Preservation Fee (Fee) of one dollar per Center event ticket is approved. The Fee will be assessed and collected on all tickets sold on and after the effective date of this Ordinance.

SECTION 2. Fund No. 62-014070 entitled "Carver Center Renewal and Replacement Fund" is established.

SECTION 3. All Fees collected will be deposited as collected into Fund No. 62-014070, Carver Center Renewal and Replacement Fund in Index Code 084798 entitled "Preservation Fees" and shall be administered by the Department of Community Initiative's Fiscal Section. Amounts deposited to the Carver Center Renewal and Replacement Fund shall be used for the maintenance and repair of the Center's facilities.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes as necessary to carry out the purpose of this Ordinance.


SECTION 5. This ordinance shall become effective on and after October 3, 2004.
