

AN ORDINANCE **99796**

**AUTHORIZING AN ADVISORY SERVICES AGREEMENT
IN THE AMOUNT OF \$110,000.00 BETWEEN THE CITY
OF SAN ANTONIO AND THE URBAN LAND INSTITUTE
(ULI), TO DEVELOP A CONCEPT PLAN AND
RECOMMEND MARKETING AND DEVELOPMENT
STRATEGIES FOR THE EAST COMMERCE STREET
CORRIDOR, BETWEEN IH-37 AND MONUMENTAL.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, Interim City Manager, Deputy City Manager, the Assistant City Manager or an Assistant to the City Manager are hereby authorized to execute an Advisory Services Agreement for the amount of \$110,000.00, to perform services related to the development of a concept plan and recommending marketing and development strategies for the East Commerce Street Corridor, between IH-37 and Monumental. Attachment 1 is attached hereto for informational purposes only; final execution of the Agreement shall be contingent upon review by the Office of the City Attorney and compliance with all internal City regulations, including but not limited to SBEDA requirements.

SECTION 2. Funds in the amount of \$110,000.00 are authorized to be encumbered in Fund 29-026000 (Office of Management and Budget) in Index Code 262683 entitled "Fees To Professional Contractors-Inner City" made payable to the Urban Land Institute.



SECTION 4. This ordinance shall take effect on October 3, 2004.
