

AN ORDINANCE

AUTHORIZING THE EXECUTION OF A CHILD CARE LOCAL MATCH CONTRIBUTION AGREEMENT WITH ALAMO WORKFORCE DEVELOPMENT, INC. (AWD), WHICH PLEDGES CERTIFICATION OF LOCAL EXPENDITURES IN THE AMOUNT OF \$1,844,171.00 TO BE USED AS LOCAL MATCH TO GENERATE FEDERAL FUNDS OF \$3,663,733.00 IN CONNECTION WITH THE OPERATION OF THE ALAMO AREA CHILD CARE DELIVERY SYSTEM (CCDS) PROGRAM; AUTHORIZING CERTIFICATION OF SAID EXPENDITURES IN CONNECTION THEREWITH; AUTHORIZING THE ACCEPTANCE OF FEDERAL FUNDS IN THE AMOUNT OF \$3,663,733.00 FOR THE PROVISION OF CHILD CARE SERVICES; AND REVISING THE CCDS PROGRAM BUDGET.

WHEREAS, the City of San Antonio, through its Child Care Delivery System (CCDS) Division of the Department of Community Initiatives, was awarded a contract with Alamo Workforce Development, Inc. (AWD) with Texas Workforce Commission (TWC) funds to serve as the operator for the Alamo Area CCDS Program for the period of September 1, 2003 through August 31, 2005 for the Alamo Workforce Development Area; and

WHEREAS, the TWC has insufficient appropriations of state match funds necessary to fully utilize the available federal child care funds and requires local communities to match funds for the CCDS Program; and

WHEREAS, funds were appropriated from the City General Fund for this purpose; and

WHEREAS, through the certification of local expenditures in the amount of \$1,844,171.00, additional federal funds from AWD in the amount of \$3,663,733.00 have been awarded for the provision of childcare services; and

WHEREAS, it is now necessary to authorize the execution of a local match agreement, which pledges certification of local expenditures, authorizes said expenditures, authorize the acceptance of federal funds in connection therewith, and approves a revised CCDS program budget; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the Department of Community Initiatives are authorized to execute a Child Care Local Match Contribution Agreement with Alamo Workforce Development, Inc. (AWD), which pledges the certification of local expenditures in the amount of \$1,844,171.00 to use as local matching funds to generate \$3,663,733.00 in federal funds in connection with the Child Care Delivery System (CCDS) program. A copy of the Child Care Local Match Contribution Agreement is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The City Manager, or her designee, or the Director of the Department of Community Initiatives is authorized to certify local expenditures in the amount of \$1,844,171.00 with AWD in connection with the Child Care Local Match Contribution Agreement.

SECTION 3. The City Manager or her designee, or the Director of the Department of Community Initiatives, is authorized to accept \$3,663,733.00 in federal match funds for the provision of child care services.


SECTION 4. The revised budget for Project No. 26-039017 entitled "Child Care Delivery System 2004-2005", attached hereto and incorporated herein for all purposes as Attachment II, is approved.

SECTION 5. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, subject to concurrence by the City Manager or THE City Manager's designee, may correct the allocations to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 6. This ordinance shall be effective on and after October 3, 2004.
