

**AN ORDINANCE**

APPOINTING THE FOLLOWING INDIVIDUALS TO THE HEAD START COMMISSION FOR A ONE YEAR TERM BEGINNING OCTOBER 1, 2004 AND ENDING SEPTEMBER 30, 2005: TALIA NYE-KEIF (MAYOR), CATHLEEN MCAULIFFE (COUNCIL DISTRICT (CD)1), LINN WAITERS (CD2), ANGIE VILLELA, (CD3), JACQUELINE MARTINEZ (CD4), TAMMY MORALES (CD5), ROSEMARY PEREZ, (CD6), TIVY WHITLOCK (CD7), YOLANDA CUELLAR (CD8), RUBEN CORTEZ (CD9) AND DONNA BAUER (CD10).


**SECTION 2.** This ordinance shall become effective on and after October 3, 2004.


