

AN ORDINANCE      **99782**

**AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO RENEW A CONTRACT WITH SELRICO SERVICES, INC., TO PROVIDE THE DEPARTMENT OF COMMUNITY INITIATIVES WITH MEAL PREPARATION AND DELIVERY SERVICES FOR THE CNP FOR THE PERIOD OF OCTOBER 1, 2004 THROUGH SEPTEMBER 30, 2005 FOR AN APPROXIMATE COST OF \$2,272,705.00; AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE UPON PASSAGE BY EIGHT AFFIRMATIVE VOTES.**

**WHEREAS**, on August 7, 2003, through Ordinance No. 97959, the City Council accepted the best value bid of Selrico Services, Inc. (the "Contract"), to provide the City of San Antonio Community Initiatives Department ("DCI") with meal preparation services in support of the Comprehensive Nutrition Project ("CNP"), administered by DCI's Elderly and Disabled Services Division; and

**WHEREAS**, the Contract provides for a one-year term, with the option to renew for three (3) additional successive one-year terms, subject to appropriation of funds therefore; and

**WHEREAS**, the cost for this renewal period is approximately \$2,272,705.00; and

**WHEREAS**, the City anticipates receiving a grant from the Alamo Area Council of Governments ("AACOG") in partial support of the CNP, which will be supplemented by other funds available to the City in fiscal year 2004; and

**WHEREAS**, the City now wishes to extend this Contract for an additional one-year period, to begin on October 1, 2004 and continue through September 30, 2005, subject to receipt of the AACOG grant and appropriation of other funding therefore; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager, or her designee, or the Director of the Purchasing & General Services, is hereby authorized to renew the contract with Selrico Services, Inc. to provide food preparation and delivery services to the City of San Antonio for the CNP for the period from October 1, 2004 through September 30, 2005, under the same terms and conditions, at a cost of approximately \$2,272,705.00. A copy of the Renewal and Extension Agreement, in substantially final form, is attached hereto and incorporated herein as Attachment I.

**SECTION 2.** Funding will not be expended by this ordinance. The approval of the contract specified in this ordinance is expressly contingent upon appropriation of funds.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager

or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 4.** This ordinance shall take effect immediately upon passage by eight affirmative votes.
