

AN ORDINANCE 99661.

**AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO EXECUTE AN AGREEMENT WITH THE METROPOLITAN PLANNING ORGANIZATION (MPO) AND ACCEPTING REIMBURSEMENT FROM THE MPO IN AN AMOUNT NOT TO EXCEED \$130,000.00; AND ADOPTING A PERSONNEL COMPLEMENT FOR ONE TWO-YEAR STAFF POSITION ENTITLED HIKE AND BIKE COORDINATOR (SPECIAL PROJECT COORDINATOR).**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is hereby authorized to execute an Agreement with the Metropolitan Planning Organization to receive reimbursement of expenses in an amount not to exceed \$130,000.00 to fund one staff position (Hike and Bike Coordinator) for two years. A copy of the Agreement is attached hereto and incorporated herein as **Attachment I**. The Agreement shall be executed within sixty days of the effective date of this Ordinance or the agreement must be considered through a subsequent ordinance.

**SECTION 2.** The creation of the additional personnel position is hereby approved and the Director of Finance shall be authorized to appropriate necessary funds for the establishment of additional personnel when deemed necessary.

**SECTION 3.** The personnel complement set out in **Attachment II** is hereby authorized and approved for one personnel position for a Hike and Bike Coordinator (Special Project Coordinator) to assist in the Bicycle Master Plan finalization and implementation.

**SECTION 4.** Funds in the amount of \$130,000.00 will be appropriated and encumbered in the General Fund (Fund 11). This Ordinance provides for reimbursement of funds expended in support of staffing for the MPO planning process. The amount of up to \$130,000.00 will be reimbursed to the City from the Metropolitan Planning Organization (MPO). This amount will be returned to said Fund when reimbursement is made by MPO.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This ordinance shall be effective on the 12th day of September, 2004.
