

AN ORDINANCE

AMENDING ORDINANCE NO. 90485, PASSED AND APPROVED ON SEPTEMBER 16, 1999, BY REALLOCATING \$16,722.63 FROM THE FISCAL YEAR 2000 COUNCIL DISTRICT 5 ONE-TIME PROJECTS FUND DESIGNATED FOR THE CORRIDOR REVITALIZATION PROJECT TO ELEVEN COMPREHENSIVE NUTRITION PROJECT CENTERS; AUTHORIZING THE EXECUTION OF CONTRACTS WITH SAID CENTERS FOR SUPPLIES AND EQUIPMENT; AND AUTHORIZING PAYMENT.

WHEREAS, the City Council passed and approved the Fiscal Year (FY) 2000 Budget Ordinance Number 90485, on September 16, 1999 allocating Council District 5 One-Time Projects Funds for various community initiatives; and

WHEREAS, the Comprehensive Nutrition Project (CNP) provides congregate and home delivered meals and supportive services principally to senior citizens; and

WHEREAS, eleven Comprehensive Nutrition Projects centers have requested Council District 5 for assistance in purchasing supplies and equipment to support the activities provided at the centers; and

WHEREAS, Councilman Radle has expressed her commitment to re-allocate \$16,722.63 from the Council District 5 One-Time Projects Fund to support said expenditures; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 90485, passed and approved on September 16, 1999 is hereby amended by reallocating \$16,722.63 from the District 5 Fiscal Year 2000 One Time Projects Fund designated to the Corridor Revitalization Project to the following eleven Comprehensive Nutrition Project Centers: St. Alphonsus Catholic Church, Our Lady of Angels Catholic Church, Our Lady of Guadalupe Catholic Church, Christ the King Church, Palacio del Sol-Mexican American Unity Council, Sacred Heart Catholic Church, St. Timothy Catholic Church, St. Jude's Catholic Church, Holy Family Catholic Church, St. James Housing Trust, Inc. and West End Park Senior Center.

SECTION 2. The City Manager or her designee, or the Director of the Department of Community Initiatives is authorized to execute a contract with the following entities for the amounts listed below for supplies and equipment in support of its senior nutrition program, which provides family strengthening and community recreational activities for seniors residing in the City of San Antonio.

SECTION 3. The budget in Fund 11-000000 (General Fund) in Index Code 666107 is reduced by \$16,722.63.

SECTION 4. Funds in the amount of \$1,875.78 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 494054 entitled "St. Alphonsus-CNP" and are authorized for payment to St. Alphonsus Catholic Church.

Funds in the amount of \$1,850.00 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 494740 entitled "Our Lady of Angels-CNP" and are authorized for payment to Our Lady of Angels Catholic Church.

Funds in the amount of \$1,364.98 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 494963 entitled "Our Lady of Guadalupe-CNP" and are authorized for payment to Our Lady of Guadalupe Catholic Church.

Funds in the amount of \$1,104.95 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 495218 entitled "Christ the King-CNP" and are authorized for payment to Christ the King Church.

Funds in the amount of \$1,200.00 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 495531 entitled "Palacio del Sol-MAUC-CNP" and are authorized for payment to the Mexican American Unity Council.

Funds in the amount of \$1,864.98 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 496331 entitled "Sacred Heart-CNP" and are authorized for payment to Sacred Heart Catholic Church.

Funds in the amount of \$759.79 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 496604 entitled "St. Timothy-CNP" and are authorized for payment to St. Timothy Catholic Church.

Funds in the amount of \$1,995.00 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 494757 entitled "St. Jude-CNP" and are authorized for payment to St. Jude Catholic Church.

Funds in the amount of \$2,000.00 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 494971 entitled "Holy Family-CNP" and are authorized for payment to Holy Family Catholic Church.

Funds in the amount of \$1,357.15 are re-appropriated and encumbered in Fund 11-000000 (General Fund) in Index Code 495226 entitled "St. James-CNP" and are authorized for payment to St. James Housing Trust, Inc.

Funds in the amount of \$1,350.00 are re-appropriated in Fund 11-000000 (General Fund) in Index Code 494765 entitled "West End Park Senior Center-CNP."



The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.
