

AN ORDINANCE **99325**

AUTHORIZING THE REAPPROPRIATION OF \$19,000.00 OF THE FISCAL YEAR 2004 COUNCIL DISTRICT 9 HUMAN DEVELOPMENT SERVICES FUND AND THE REAPPROPRIATION OF \$20,000.00 OF FISCAL YEAR 2004 COUNCIL DISTRICT 10 HUMAN DEVELOPMENT SERVICES FUND TO THE FAMILIES SAVE INDIVIDUAL DEVELOPMENT ACCOUNT (IDA) PROJECT; AND REVISING THE FAMILIES SAVE IDA BUDGET.

WHEREAS, through Ordinance No. 98181, passed and approved on September 18, 2003, the City Council adopted human development guidelines to be followed for the expenditure of human development funds for projects that are open to members of the public who meet certain eligibility requirements; and

WHEREAS, pursuant to said ordinance, the City Council also adopted the FY04 Operating Budget providing Human Development Services Funds to the Mayor and each of the Councilmembers; and

WHEREAS, Council Districts 9 and 10 desire to provide scholarships for higher education to residents of Council Districts 9 and 10 respectively; and

WHEREAS, Council District 9 and Council District 10 desire to provide match funding for the Families SAVE Individual Development Account (IDA) Project to be used for college scholarships for eligible students residing in Council District 9 and Council District 10; and

WHEREAS, the Families SAVE IDA Project provides human development related services in the priority area of higher education; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The budget in Fund 11, General Fund, Index Code 725812 entitled "District 9 Human Development Services Fund" is authorized to be reduced by \$19,000.00.

SECTION 2. The budget in Fund 11, General Fund, Index Code 725952 entitled "District 10 Human Development Services Fund" is authorized to be reduced by \$20,000.00.

SECTION 3. The amount of \$19,000.00 is authorized to be appropriated in Fund 11, General Fund, Index Code 924811 entitled "Transfer to Project 26-022095." Said amount is also authorized to be encumbered for transfer to Project No. 26-022095.

SECTION 4. The amount of \$20,000.00 is authorized to be appropriated in Fund 11, General Fund, Index Code 924811 entitled "Transfer to Project 26-022095." Said amount is also authorized to be encumbered for transfer to Project No. 26-022095.

SECTION 5. The budget of Project No. 26-022095 entitled "Families SAVE Program/2" is authorized to be revised in accordance with the budget schedule affixed hereto and incorporated herein for all purposes as Attachment I.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Project Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 7. This Ordinance shall become effective on June 20, 2004.
