

AN ORDINANCE

ACCEPTING THE LOW RESPONSIVE BIDS SUBMITTED BY  
CREATIVE PIPE, INC. AND ALAMO IRON WORKS TO PROVIDE  
THE CITY OF SAN ANTONIO PUBLIC WORKS DEPARTMENT  
WITH BICYCLE RACKS FOR A TOTAL OF \$30,496.50.

WHEREAS, bids were submitted to provide the City of San Antonio Public Works Department with bicycle racks; and

WHEREAS, the low bids were submitted by Creative Pipe, Inc. to provide type 1 bicycle rack sets and Alamo Iron Works to provide type 2 cactus sharp bicycle rack sets for a total amount of \$30,496.50; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The bids submitted by Creative Pipe, Inc. to provide type 1 bicycle rack sets and Alamo Iron Works to provide type 2 cactus sharp bicycle rack sets to the City of San Antonio Public Works Department for a total amount of \$30,496.50 are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. All other bids will be considered rejected upon the successful bidder's completion of all conditions precedent to award or the expiration of sixty days from the effective date hereof, whichever occurs first. Attached hereto and incorporated herein for all purposes as Attachment A are the bids and bid tabulation sheets.

**SECTION 2.** Funds in the amount of \$24,984.00 will be encumbered in Fund 29 (Miscellaneous Special Revenue Fund) in Index Code 356105 entitled "Maintenance and Repair Materials Buildings & Improvements" to be made payable to Alamo Iron Works.

**SECTION 3.** Funds in the amount of \$5,512.50 will be encumbered in Fund 43 (Certificates of Obligation) in Index Code 763110 entitled "Bike Racks & Materials" to be made payable to Creative Pipe, Inc.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 5.** This ordinance shall take effect August 15<sup>th</sup>, 2004.
