

AN ORDINANCE

AMENDING ORDINANCE NO. 97239, PASSED AND APPROVED ON FEBRUARY 27, 2003, BY REVISING THE OFFICIAL CITY STORE TICKET CONSIGNMENT POLICY TO AUTHORIZE THE EXECUTIVE DIRECTOR OF THE CONVENTION AND VISITORS BUREAU, OR HIS DESIGNEE, TO NEGOTIATE AND EXECUTE AGREEMENTS, UPON CONSULTATION WITH THE CITY ATTORNEY, FOR THE RESALE OF LOCAL ATTRACTION CONSIGNMENT TICKETS IN THE OFFICIAL CITY STORE, IN LIEU OF THE DIRECTOR OF ASSET MANAGEMENT, AND MODIFYING THE OFFICIAL CITY STORE TICKET CONSIGNMENT AGREEMENT TO REFLECT THIS REVISION.

WHEREAS, the City of San Antonio owns and operates a retail store known as the Official City Store located at 317 Alamo Plaza; and

WHEREAS, in order to help promote the City's attractions and help the City of San Antonio achieve its goal of becoming the premier visitors' and convention destination, the Official City Store sells tickets for theme parks, water parks and other attractions located in the Bexar County area on a consignment basis; and

WHEREAS, by the passage of Ordinance No. 97239, approved on February 27, 2003, City Council adopted the policies found in the Official City Store Ticket Consignment Policy ("Policy"), approved the Official City Store Ticket Consignment Agreement ("Agreement") for the consignment of tickets to be sold at the Official City Store, and authorized the Director of Asset Management to serve as the City Store representative for the purpose of negotiating and executing said Agreement upon consultation with the City Attorney; and

WHEREAS, the Official City Store, which was formerly under the Department of Asset Management, is now operated by the Convention and Visitors Bureau; and

WHEREAS, this Ordinance revises the Policy to authorize the Executive Director of the Convention and Visitors Bureau, or his designee, to negotiate and execute Agreements, upon consultation with the City Attorney, in place of the Director of Asset Management and modifies the Agreement to reflect this change; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 97239, passed and approved on February 27, 2003, is hereby amended by revising the Official City Store Ticket Consignment Policy to authorize the Executive Director of the Convention and Visitors Bureau, in place of the Director of Asset Management, to negotiate and execute Official City Store Ticket Consignment Agreements for the resale of local attraction consignment tickets at the Official City Store, upon consultation with the City Attorney, as set forth in Attachment I hereto.

SECTION 2. The Official City Store Ticket Consignment Agreement, previously approved by Ordinance No. 97239, passed and approved on February 27, 2003, is hereby modified, as set forth in Attachment II hereto, and the Executive Director of the Convention and Visitors Bureau, or his designee, is hereby authorized to serve as the City Store representative for the purpose of negotiating and executing said Agreement.

SECTION 3. This ordinance shall take effect on the tenth day from the date of passage hereof.




