

AN ORDINANCE 99629

AUTHORIZING THE EXECUTION OF A CONTRACT WITH PARENT/CHILD INCORPORATED (PCI) IN THE AMOUNT OF \$44,666,896.00 FOR THE SAN ANTONIO/BEXAR COUNTY HEAD START-EARLY CHILD CARE PROGRAM FOR THE PERIOD OF FEBRUARY 1, 2004 THROUGH JANUARY 31, 2005; RATIFYING THE REIMBURSEMENT OF EXPENDITURES TO PCI SINCE FEBRUARY 1, 2004 FOR CONTINUITY OF SAID PROGRAM; AND ADOPTING A REVISED HEAD START-EARLY CHILD CARE PROGRAM BUDGET.

WHEREAS, Ordinance No. 98768, passed and approved on January 29, 2004, authorized the acceptance of a continuation grant from the U.S. Department of Health and Human Services (HHS) for the Head Start – Early Child Care program in the amount of \$45,104,728.00 for a twelve month period beginning February 1, 2004; and

WHEREAS, these grant funds provide a wide range of education and social services to low income pre-school children and their families including educational, health, mental health and disability services provided at 87 child development centers throughout San Antonio and Bexar County to children ranging from three to five years of age; and

WHEREAS, the City has been paying Parent/Child, Incorporated (PCI) since February 1, 2004 to operate the Head Start program and now desires to execute a contract with PCI to continue the Head Start Program; and

WHEREAS, it is now necessary to ratify the reimbursement of said expenditures to PCI since February 1, 2004, authorize the execution of a contract for the period of February 1, 2004 to January 31, 2005, and adopt a revised Head Start Program Budget to reflect said actions; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the Department of Community Initiatives, is hereby authorized to execute a contract with Parent/Child, Incorporated (PCI) in the amount of \$44,666,896.00 for the period of February 1, 2004 through January 31, 2005 for the purposes of operating the Head Start-Early Child Care program for San Antonio and Bexar County. A copy of said contract is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The reimbursement of expenditures to PCI since February 1, 2004 necessary for continuity of services from Project No. 26-022101, entitled Head Start – Early Child Care Program 2004, is hereby ratified.

SECTION 3. The revised budget for Project No. 26-022101, entitled Head Start – Early Child Care Program 2004, attached hereto and incorporated herein for all purposes as Attachment II, is hereby adopted.




SECTION 5. This ordinance shall become effective on and after September 5, 2004.
