

AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF A CONTRACT IN AN AMOUNT NOT TO EXCEED \$40,000.00 FROM CHRISTUS SANTA ROSA HEALTH CARE ("CSRHC") IN ORDER FOR THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT TO PROVIDE PATIENT CARE MANAGEMENT, OUTREACH, EDUCATION AND FACILITATION OF COMMUNITY COALITION ACTIVITIES IN SUPPORT THE CSRHC MOBILE MAMMOGRAPHY PROGRAM FOR THE PERIOD OCTOBER 1, 2004 THROUGH SEPTEMBER 30, 2006; AND AUTHORIZING THE EXECUTION OF THE CONTRACT WITH CSRHC.

WHEREAS, the San Antonio Metropolitan Health District (SAMHD) operates breast cancer screening and follow-up programs for uninsured, low-income women in Bexar County and in surrounding counties; and

WHEREAS, CHRISTUS Santa Rosa Health Care (CSRHC) has been awarded a grant from the CDC Foundation for a mobile mammography program to provide services for uninsured, low-income women who reside in the greater San Antonio area for the period October 1, 2004 through September 30, 2006; and

WHEREAS, CSRHC desires to contract with the City of San Antonio for the SAMHD to provide for patient case management, outreach, education services, and facilitation of community coalition building activities in support of this program for the period October 1, 2004 through September 30, 2006; and

WHEREAS, it is now necessary to authorize the acceptance and execution of the contract with CSRHC for said services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to accept and execute a Mobile Mammography Unit Services Contract in an amount not to exceed \$40,000.00 from CSRHC, for the SAMHD to provide patient case management, outreach, education, and the facilitation of community coalition building services in support of the CSRHC Mobile Mammography Program for the period of October 1, 2004 through September 30, 2006. A copy of the Mobile Mammography Unit Services Contract is set out as Attachment II and incorporated herein for all purposes.

SECTION 2. Fund No. 26-012273 entitled "CSRHC Mobile Mammography Program" is hereby designated for use in accounting for the above program.

SECTION 3. The aggregate sum of \$40,000.00 is hereby appropriated in the above-designated fund for the CSRHC Mobile Mammography Program and the budget set out in Attachment I is approved and adopted for entry on the City books.

SECTION 4. The one (1) personnel position set out in Attachment I is hereby authorized for the activity thereon.

SECTION 5. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 6. Should the contract be in an amount other than that budgeted for, or should the contract contain terms and conditions different than those currently existing, acceptance of the contract, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.


SECTION 7. This ordinance shall be effective on and after September 26, 2004.
