**RATIFYING CHANGE ORDERS 26 THROUGH 68, INCREASING THE CONTRACT WITH ERICSSON, INC IN THE AMOUNT OF \$471,523.00 TO OPTIMIZE SYSTEM PERFORMANCE AND FUNCTIONALITY TO ENSURE THE SAFETY OF PUBLIC SAFETY OFFICERS, FIREFIGHTERS, EMS PERSONNEL AND OTHER LOCAL GOVERNMENT USERS.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Change orders 26 through 68, in connection with the Ericsson, Inc., radio contract are hereby approved. A copy of these change orders is attached hereto and incorporated herein for all purposes as Exhibit A.

**SECTION 2.** The amount of \$471,523.00 is appropriated in fund 40-009001, Other Capital Projects, Public Safety Radio System, in index code 658013, entitled Radio System Equipment, and is authorized to be encumbered and made payable to Ericsson, Inc., in connection with the Public Safety Radio System project.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This ordinance shall take effect on October 10, 2004.


