

AN ORDINANCE      99861

**AUTHORIZING THE ACCEPTANCE OF \$305,776.00 FROM THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES ("TDSHS") TO RENEW FUNDING FOR THE LOCAL PUBLIC HEALTH SUPPORT PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT FOR THE PERIOD SEPTEMBER 1, 2004 THROUGH AUGUST 31, 2005; AUTHORIZING THE EXECUTION OF THE CONTRACT CHANGE WITH TDSHS; ADOPTING THE PROGRAM BUDGET; AND APPROVING THE PERSONNEL COMPLEMENT.**

**WHEREAS**, the Texas Department of State Health Services (TDSHS), formerly known as the Texas Department of Health (TDH), provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of various comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

**WHEREAS**, Ordinance No. 98536, passed and approved on December 4, 2003, authorized the execution of Contract 7460020708 2005 between the City of San Antonio and DSHS, covering operation of the Public Health State Support Project 2004/2005 of the SAMHD; and

**WHEREAS**, TDSHS has now offered \$305,776.00 to continue funding the Local Public Health Support Program of the SAMHD through Contract Change Notice No. 13, Attachment No. 11 to the above contract for the period September 1, 2004 through August 31, 2005; and

**WHEREAS**, it is now necessary to authorize the acceptance of the support from TDSHS, approve the execution of the contract change notice, adopt the program budget, and approve the personnel complement; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The Interim City Manager, or his designee, is hereby authorized to accept \$305,776.00 from TDSHS to fund the Local Public Health Support Program of the SAMHD for the period September 1, 2004 through August 31, 2005. The Interim City Manager, or his designee, is further authorized to execute Contract Change Notice No. 13, Attachment No. 11 to Grant Contract 7460020708 2005 with TDSHS. A copy of Contract Change Notice No. 13, Attachment 11 is set out in Attachment II and incorporated herein for all purposes.

**SECTION 2.** Fund No. 26-016067, Internal Order 136000000241 entitled "Public Health State Support Project 2004-2005 (State)" is hereby designated for use in accounting for the fiscal

transactions of this project. This fund is authorized to be revised in accordance with Contract Change Notice No. 13, Attachment No. 11.

**SECTION 3.** The sum of \$305,776.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

**SECTION 4.** The six (6) personnel positions set out in Attachment I and incorporated herein are authorized for the activity shown thereon.

**SECTION 5.** The Director of Finance, may, subject to concurrence by the Interim City Manager or the Interim City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.

**SECTION 6.** Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

**SECTION 7.** This ordinance shall be effective on and after October 24, 2004.


