

AN ORDINANCE " 9 9 9 3 9

**ACCEPTING THE LOW RESPONSIVE BIDS SUBMITTED BY W.S. DARLEY & CO., ITEMS 2-6, AND FERRARA FIRE APPARATUS, INC., ITEM 1, TO PROVIDE THE CITY OF SAN ANTONIO FIRE DEPARTMENT WITH FIRE HOSE FOR A TOTAL COST OF \$51,668.29.**

**WHEREAS**, bids were submitted to provide the City of San Antonio Fire Department with fire hoses; and

**WHEREAS**, the low bids were submitted by W.S. Darley & Co., items 2-6, and Ferrara Fire Apparatus, Inc., item 1 for a total cost of \$51,668.29; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The bids submitted by W.S. Darley & Co., items 2-6, and Ferrara Fire Apparatus, Inc., item 1 to provide the City of San Antonio Fire Department with fire hoses for a total cost of \$51,668.29 are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. All other bids will be considered rejected upon the successful bidder's completion of all conditions precedent to award or the expiration of sixty days from the effective date hereof, whichever occurs first. Attached hereto and incorporated herein for all purposes as Attachment A are the bids and bid tabulation sheet.

**SECTION 2.** Funds in the amount of \$28,868.29 are authorized to be encumbered in cost center 2004010002, General Ledger 5304050 entitled "Commodities - Tools and Apparatus", Fund 11000000 entitled "General Fund" to W.S. Darley & Co. when a purchase order is issued.

**SECTION 3.** Funds in the amount of \$22,800.00 are authorized to be encumbered in cost center 2004010002, General Ledger 5304050 entitled "Commodities - Tools and Apparatus", Fund 11000000 entitled "General Fund" to Ferrara Fire Apparatus when a purchase order is issued.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This ordinance shall take effect November 14<sup>th</sup>, 2004.


