

AN ORDINANCE 100011

AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE SAN ANTONIO HOUSING AUTHORITY IN AN AMOUNT NOT TO EXCEED \$308,352.00 FOR THE CONTINUATION OF THE DWYER AVENUE CENTER SINGLE ROOM OCCUPANCY PROGRAM FOR THE PERIOD OF SEPTEMBER 17, 2004 TO SEPTEMBER 16, 2005.

WHEREAS, the City of San Antonio operates the Dwyer Avenue Center and provides transitional housing for single homeless persons; and

WHEREAS, the City has participated in the Single Room Occupancy (SRO) Program since 1992; and

WHEREAS, the San Antonio Housing Authority (SAHA) has received funding from the Department of Housing and Urban Development to continue the Housing Assistance Payments Program, which assists SRO residents at the Dwyer Avenue Center, for the period of September 17, 2004 to September 16, 2005; and

WHEREAS, the City's Department of Community Initiatives, Community Action Division, desires to continue the SRO Program with SAHA; and

WHEREAS, the SRO Program provides much needed transitional housing for homeless individuals in San Antonio; and

WHEREAS, it is now necessary to authorize the execution of a contract with SAHA for the continuation of the SRO program; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Interim City Manager, or in his stead, either an Assistant City Manager, an Assistant to the City Manager, or the Director of the Department of Community Initiatives, is authorized to execute a Housing Assistance Payment contract with the San Antonio Housing Authority in an amount not to exceed \$308,352.00 for the continuation of the Dwyer Avenue Center Single Room Occupancy Program for the period beginning September 17, 2004 and ending September 16, 2005. The Interim City Manager, or in his stead, either an Assistant City Manager, an Assistant to the City Manager, or the Director of the Department of Community Initiatives, is further authorized to execute such certifications and assurances as the contract requires. A copy of the contract, in substantially final form, is attached hereto and incorporated herein for all purposes as Attachment I.


SECTION 2: Revenues generated through this contract shall be deposited in SAP fund 29612000, Dwyer Center Rental Income Trust, revenue internal order 238000000041, entitled S.R.O. Rental Income Dwyer Avenue.


SECTION 3. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, subject to concurrence by the Interim City Manager, an Assistant City Manager or an Assistant to the City Manager, may correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP internal orders and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 4. This ordinance shall become effective on and after November 28, 2004.
