**AMENDING RESOLUTION NO. 2003-24-26 BY REVISING THE APPOINTMENT OF CERTAIN MEMBERS OF CITY COUNCIL TO THE METROPOLITAN PLANNING ORGANIZATION; THE FIRE AND POLICE PREFUNDED HEALTH TRUST; THE FIREMEN'S AND POLICEMEN'S PENSION FUND BOARD OF TRUSTEES; THE COMMUNITY ACTION ADVISORY BOARD; AND THE COMMITTEE OF SIX OF THE ALAMO WORKSOURCE, AS REQUESTED BY MAYOR EDWARD D. **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Adjustments are hereby made to the existing Council Committee and Board and Commission appointments shall be as follows:

- Councilman Art Hall is designated as a member of the Metropolitan Planning Organization – replacing Councilman Julian Castro.
- Councilman Chip Haass is designated as a member of the Metropolitan Planning Organization – replacing Councilman Ron Segovia.
- Councilman Richard Perez is designated as a member of the Metropolitan Planning Organization – replacing Councilman Joel Williams.
- Councilwoman Patti Radle is designated as a member of the Fire and Pension Fund Board of Trustees – replacing Councilman Carroll Schubert.
- Councilman Julian Castro is released from membership on the Community Action Advisory Board.

- Councilman Art Hall is released from membership on the Committee of Six (Alamo WorkSource) as an alternate for Mayor Edward D. Garza.

**SECTION 2.** This Resolution shall take effect on the tenth (10<sup>th</sup>) day after the date of passage hereof.


