REALLOCATING \$300.00 FROM THE FY 1999 DISTRICT 7 ONE-TIME PROJECT BUDGET BY REDUCING FUNDS SET FOR THE HOUSING REHABILITATION MODEL BLOCK PROGRAM AND AUTHORIZING \$300.00 TO THE THUNDERBIRD HILLS NEIGHBORHOOD ASSOCIATION TO HELP OFFSET THE COSTS ASSOCIATED WITH THE INSTALLATION OF A STREET LIGHT AT 6318 WIGWAM; AS REQUESTED BY COUNCILWOMAN JULIAN CASTRO, DISTRICT 7.

WHEREAS, City Councilman Julian Castro has received a request from the Thunderbird Hills Neighborhood Association in the amount of \$300.00 to help offset the cost associated with the installation of a street light at 6318 Wigwam, which City Council hereby finds supports a municipal public purpose; and

WHEREAS, in order to fund this request City Councilman Julian Castro desires to reduce funds set aside in the FY 1999 District 7 One-Time Project budget for the Housing Rehabilitation Model Block Program by the amount of \$300.00 and to re-allocate this sum to the Thunderbird Hills Neighborhood Association for the purpose set out above; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Councilman Castro to assist the Thunderbird Hills Neighborhood Association by granting them \$300.00 to help offset the costs associated with the installation of a street light at 6318 Wigwam which is attached to this ordinance as Exhibit I, is hereby approved.

SECTION 2. The Interim City Manager or a designee, is hereby authorized for a period of sixty (60) from the effective date of this ordinance, to execute an agreement with said agency which sets out the terms and conditions for receiving and using public funds. A substantially final copy of this agreement is attached to this ordinance as Exhibit 2 and will be replaced with a fully executed agreement upon final execution by the parties.

SECTION 3. The budget in cost center 7002070001, General Ledger 5201040 entitled "Fees to Professional Contractors," Fund 11001000 entitled "General Fund" for the Housing Rehabilitation Model Block Program is authorized to be reduced by \$300.00.

SECTION 4. The amount of \$300.00 is authorized to be appropriated and encumbered in cost center 7002070001, General Ledger 5201040 entitled "Fees to Professional Contractors," Fund 11001000 entitled "General Fund" for the Thunderbird Hills Neighborhood Association upon issuance of a purchase order.


