AN ORDINANCE 100127.

AUTHORIZING THE INTERIM CITY MANAGER OR HIS DESIGNEE TO ENTER A DELEGATE AGENCY CONTRACT WITH THE SAN ANTONIO SYMPHONY, IN AN AMOUNT NOT TO EXCEED \$400,000.00 IN GENERAL AND AVIATION FUNDS AS ADOPTED BY CITY COUNCIL AS PART OF THE FISCAL YEAR 2004-2005 GENERAL OPERATING BUDGET, TO SUPPORT THE OPERATIONS AND AIRPORT PROJECTS OF THE SAN ANTONIO SYMPHONY; AND PROVIDING FOR PAYMENT.

WHEREAS, in February 2004, OCA received an application from the San Antonio Symphony ("Symphony") as part of the Fiscal Year 2005 Arts Funding process requesting \$400,000 in operational support and the Symphony application, along with 41 other applications from local arts agencies, was reviewed and evaluated on pre-approved criteria; and

WHEREAS, at the conclusion of the Fiscal Year 2005 Arts Funding process, the Cultural Arts Board ("CAB") met and finalized funding recommendations for 38 agencies and did not recommend funding for the Symphony; and

WHEREAS, notwithstanding CAB's recommendation not to fund the Symphony, the Mayor and City Council amended Fiscal Year 2004-2005 Budget to fund the Symphony to include \$320,000.00 from the General Fund to provide operational support to the Symphony and \$80,000.00 from the Aviation Fund to support Symphony performances at the San Antonio International Airport; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of a Delegate Agency Contract with the San Antonio Symphony, in an amount not to exceed \$400,000.00 in General and Aviation Funds as adopted by City Council as part of the Fiscal Year 2004-2005 General Operating Budget, to support the operations and Airport projects of the San Antonio Symphony are hereby authorized and approved.

SECTION 2. The Interim City Manager or his designee is authorized for a sixty (60)-day period following the effective date of this Ordinance to execute a Delegate Agency Contract with the Symphony. A copy of said Delegate Agency Contract, previously executed by the Symphony, is attached hereto and incorporated herein as Attachment I.

SECTION 3. Funds in the amount of \$80,000.00 are authorized to be encumbered in Cost Center 3301010001, General Ledger 5407030 entitled "Contributions to Other Agencies," Fund Number 51001000 entitled "Aviation Operating Fund" and shall be made payable to the San Antonio Symphony when a purchase order is issued.


SECTION 4: Funds in the amount of \$320,000.00 are authorized to be encumbered in Cost Center 8510570001, General Ledger 5407030 entitled "Contributions to Other Agencies," Fund Number 11001000 entitled "General Fund" and shall be made payable to the San Antonio Symphony when a purchase order is issued.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance shall be effective on and after the tenth day after passage hereof.


