

AN ORDINANCE      1 0 0 9 8 8

AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES – ADMINISTRATION FOR CHILDREN AND FAMILIES IN THE AMOUNT OF \$35,000.00 FOR THE PURCHASE OF CHILD RESTRAINTS/AUTO SAFETY SEATS AND CLASSROOM COMPUTERS FOR THE HEAD START EARLY CHILD CARE PROGRAM; REVISING THE CITY'S 2005 HEAD START EARLY CHILD CARE PROGRAM BUDGET IN CONNECTION THEREWITH; AUTHORIZING THE EXECUTION OF A CONTRACT AMENDMENT WITH PARENT/CHILD, INCORPORATED (PCI) INCREASING THE TOTAL AMOUNT OF THE CONTRACT BY \$35,000.00 FOR A TOTAL CONTRACT AMOUNT OF \$45,398,107.00 AND REVISING THE PCI HEAD START PROGRAM BUDGET IN ACCORDANCE THEREWITH.

**WHEREAS**, Ordinance No. 100361, passed and approved on January 27, 2005, authorized the acceptance of a continuation grant from the U.S. Department of Health and Human Services – Administration for Children and Families (HHS-ACF) for the Head Start – Early Child Care program in the amount of \$45,833,107.00 for a twelve month period beginning February 1, 2005; and

**WHEREAS**, these grant funds provide a wide range of education and social services to impoverished pre-school children and their families including educational, health, mental health and disability services provided at 87 child development centers throughout San Antonio and Bexar County to children ranging from three to five years of age; and

**WHEREAS**, HHS-ACF has awarded additional financial assistance to the City of San Antonio in the amount of \$35,000.00 for the purchase of child restraints and classroom computers for the Head Start Early Child Care Program; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**Section 1.** The Interim City Manager, or his designee, or the Director of the Department of Community Initiatives is authorized to accept a grant award from the U.S. Department of Health and Human Service – Administration of Children and Families in the amount of \$35,000.00, for the purchase of child restraints/auto safety seats and classroom computers for the Head Start Early Child Care Program. A copy of the grant award is attached hereto and incorporated herein for all purposes as Attachment I.


**Section 2.** The revised budget for Fund 26022000, Internal Order 138000000305 and 138000000309, entitled, "2005 Head Start Early Child Care Program" is attached hereto and incorporated herein for all purposes as Attachment II, is approved.

**Section 3.** The Interim City Manager, or his designee, or the Director of the Department of Community Initiatives is authorized to execute a contract amendment with Parent/Child Incorporated (PCI) increasing the total amount of the PCI contract by \$35,000.00 for a total contract amount of \$45,398,107.00 and revising the PCI Head Start Program Budget in accordance therewith. A copy of said contract amendment, in substantially final form, is attached hereto and incorporated herein for all purposes as Attachment III.


**Section 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the Interim City Manager, or the Interim City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Cost Centers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**Section 5.** This ordinance shall become effective on and after June 12, 2005.
