

AN ORDINANCE 100276

ACCEPTING THE LOW RESPONSIVE BID SUBMITTED BY JOE HARRISON MOTOR, INC., D/B/A JOE HARRISON MOTOR SPORTS TO PROVIDE THE CITY OF SAN ANTONIO POLICE DEPARTMENT WITH ELEVEN (11) REPLACEMENT POLICE MOTORCYCLES FOR A TOTAL COST OF \$177,419.00.

WHEREAS, bids were submitted to provide the City of San Antonio Police Department with eleven (11) replacement police motorcycles; and

WHEREAS, the low bid was submitted by Joe Harrison Motor, Inc., d/b/a Joe Harrison Motor Sports for a total cost of \$177,419.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Joe Harrison Motor, Inc., d/b/a Joe Harrison Motor Sports to provide the City of San Antonio Police Department with eleven (11) replacement police motorcycles for a total cost of \$177,419.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. All other bids will be considered rejected upon the successful bidder's completion of all conditions precedent to award or the expiration of sixty days from the effective date hereof, whichever occurs first. Attached hereto and incorporated herein for all purposes as Attachment A is the bid and bid tabulation sheet.

SECTION 2. Funds were appropriated in the Fiscal Year 2005 budget process, and the funds will be encumbered in Cost Center 1503030000, General Ledger 5709060 entitled, "CO>5K - Machinery & Equipment", in Fund 72001000, entitled "Equipment Renewal & Replacement", upon issuance of a purchase order.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance shall take effect January 23rd, 2005.


