

AN ORDINANCE 101498

**AUTHORIZING THE EXECUTION OF ONE-YEAR INTERLOCAL AGREEMENTS FOR EMERGENCY MEDICAL SERVICES WITH THE SUBURBAN CITIES OF BALCONES HEIGHTS, CASTLE HILLS, HELOTES AND WINDCREST, EFFECTIVE OCTOBER 1, 2005 THROUGH SEPTEMBER 30, 2006.**

**WHEREAS**, suburban cities have received emergency medical services (“EMS”) from the San Antonio Fire Department on a contractual basis for over 25 years and the terms and conditions of the proposed Interlocal Agreements (“Agreements”) with the cities of Balcones Heights, Castle Hills, Helotes and Windcrest will remain the same as the previous agreements; and

**WHEREAS**, the fees for the suburban cities are based on a formula which includes the respective pro-rata share of each city’s residential electrical connections and the EMS net operating budget for the fiscal year; and

**WHEREAS**, while in the past the electrical connections in the unincorporated area of Bexar County have been factored into the overall number of connections, these Agreements will no longer continue that practice; and

**WHEREAS**, it is estimated that in Fiscal Year 2005-2006 the EMS fees for the four suburban cities will total approximately \$502,281.00, which represents a ten percent (10%) increase from Fiscal Year 2004-2005; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The terms and conditions of Interlocal Agreements for emergency medical services with Balcones Heights, Castle Hills, Helotes and Windcrest, for the period October 1, 2005 through September 30, 2006, are authorized and approved.

**SECTION 2.** The City Manager or designee is authorized, for a sixty (60)-day period following the effective date of this Ordinance, to execute Interlocal Agreements with Balcones Heights, Castle Hills, Helotes and Windcrest. Copies of these Interlocal Agreements will be attached to this Ordinance upon final execution.

**SECTION 3.** Funds in the amount of \$78,877.00 are authorized to be deposited in Fund 29003000 entitled “Emergency Ambulance Service Fund”, Internal Order Number 220000000001 entitled “EMS Administration”, General Ledger 4402210 entitled

“Contribution: Balcones Heights EMS” when received.

**SECTION 4.** Funds in the amount of \$111,948.00 are authorized to be deposited in Fund 29003000 entitled “Emergency Ambulance Service Fund”, Internal Order Number 220000000001 entitled “EMS Administration”, General Ledger 4402211 entitled “Contribution: Castle Hills EMS” when received.

**SECTION 5.** Funds in the amount of \$145,887.00 are authorized to be deposited in Fund 29003000 entitled “Emergency Ambulance Service Fund”, Internal Order Number 220000000001 entitled “EMS Administration”, General Ledger 4402216 entitled “Contribution: Helotes EMS” when received.

**SECTION 6.** Funds in the amount of \$165,570.00 are authorized to be deposited in Fund 29003000 entitled “Emergency Ambulance Service Fund”, Internal Order Number 220000000001 entitled “EMS Administration”, General Ledger 4402215 entitled “Contribution: Windcrest EMS” when received.

**SECTION 7.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 8.** This Ordinance shall be effective immediately upon the passage of eight (8) affirmative votes. If it is not passed by (8) affirmative votes, this Ordinance shall be effective on and after the tenth day after passage.


