

AN ORDINANCE 100318

AUTHORIZING THE INTERIM CITY MANAGER OR HIS DESIGNEE TO RENEW A PROFESSIONAL SERVICES AGREEMENT WITH THE SAN ANTONIO MOBILITY COALITION, INC., ("SAMCO") AND APPROVING PAYMENTS IN AN AMOUNT NOT TO EXCEED \$70,000.00 TO SAMCO FOR ANNUAL MEMBERSHIP DUES BEGINNING FEBRUARY 1, 2005 THROUGH JANUARY 31, 2006 FOR THE CITY OF SAN ANTONIO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute an Agreement for membership with the San Antonio Mobility Coalition, Inc., and authorizing payment in the amount of \$70,000.00 for annual dues. A copy of said Agreement is affixed hereto as Attachment I.

SECTION 2. Funds were appropriated in the Fiscal Year 2005 budget process, and funds will be encumbered in Cost Center 8002430001, General Ledger 5203050 entitled, "Membership Dues", in Fund 11001000, entitled "General Fund", in the amount of \$70,000.00. Payment is authorized to San Antonio Mobility Coalition, Inc. in the amount of \$70,000.00 for annual membership dues beginning February 1, 2004 through January 31, 2006 for the City of San Antonio.

SECTION 3. Funds were appropriated in the Fiscal Year 2005 budget process, and funds will be encumbered in Cost Center 8002430001, General Ledger 5203050 entitled, "Membership Dues", in Fund 11001000, entitled "General Fund", in the amount of \$70,000.00. Payment is authorized to San Antonio Mobility Coalition, Inc. in the amount of \$70,000.00 for annual membership dues beginning February 1, 2004 through January 31, 2006 for the City of San Antonio.


SECTION 4. This ordinance shall take effect on the 30th day of January, 2005.


