

AN ORDINANCE 100307

AUTHORIZING THE ACCEPTANCE OF \$321,254.00 FROM THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES (TDSHS) TO RENEW SUPPORT FOR THE SEXUALLY TRANSMITTED DISEASE (STD) STAFF SUPPORT PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT FOR THE PERIOD JANUARY 1, 2005 THROUGH DECEMBER 31, 2005; AUTHORIZING THE EXECUTION OF THE CONTRACT CHANGE WITH TDSHS; ADOPTING THE PROGRAM BUDGET; AND APPROVING THE PERSONNEL COMPLEMENT.

WHEREAS, the Texas Department of State Health Services (TDSHS) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of various comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

WHEREAS, Ordinance No. 100270, passed and approved on January 13, 2005, authorized the execution of Contract 7460020708 2006 between the SAMHD and the TDSHS, covering operation of the Public Health State Support Project 2005/2006 – Federal of the SAMHD; and

WHEREAS, the TDSHS has now issued Contract Change Notice No. 02, Attachment No. 03, to the above contract which will provide \$321,254.00 to renew support for the ongoing Sexually Transmitted Disease (STD) Staff Support Program of the SAMHD for the period January 1, 2005 through December 31, 2005; and

WHEREAS, it is now necessary to authorize acceptance of the funds and execution of the contract change notice with TDSHS, adopt the program budget and approve the personnel complement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Interim City Manager, or his designee, is hereby authorized to accept \$321,254.00 from the TDSHS in order to renew support for the Sexually Transmitted Disease (STD) Staff Support Program of the SAMHD for the period January 1, 2005 through December 31, 2005. The Interim City Manager, or his designee, is further authorized to execute Contract Change Notice No. 02, Attachment No. 03, to Grant Contract 7460020708 2006, with TDSHS. A copy of Contract Change Notice No. 02 is set out in Attachment II and incorporated herein for all purposes.

SECTION 2. SAP Fund No. 26016000 entitled "Public Health State Support Project 2005/2006 – Federal", Funds Center 3607290000, Internal Order 136000000259, is hereby designated for use in accounting for the fiscal transactions of this program. Said fund is authorized to be revised in accordance with Contract Change Notice No. 02.

SECTION 3. The sum of \$321,254.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

SECTION 4. The eight (8) personnel positions set out in Attachment I and incorporated herein are authorized for the activity shown thereon.

SECTION 5. The Director of Finance may, subject to concurrence by the Interim City Manager or the Interim City Manager's designee, correct allocation to specific internal order numbers, account numbers and fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 6. Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

SECTION 7. This ordinance shall be effective on and after January 30, 2005.


