REAPPOINTING BART HUFFMAN (DISTRICT 8), HENRY FELDMAN (DISTRICT 8 AND MAYOR) AND MICHAEL TEASE (DISTRICT 2) TO THE HOTEL/MOTEL ASSOCIATION CATEGORY FOR TERMS OF OFFICE TO EXPIRE ON JUNE 30, 2006; APPOINTING MARILYN DESIMONE (DISTRICT 9) TO THE HOTEL/MOTEL ASSOCIATION CATEGORY FOR A TERM OF OFFICE TO EXPIRE ON JUNE 30, 2005; APPOINTING DR. TOM CANNON (DISTRICT 6) TO THE SAN ANTONIO AREA TOURISM COUNCIL CATEGORY FOR A TERM OF OFFICE TO EXPIRE ON JUNE 30, 2006; APPOINTING DANIEL DECKER (DISTRICT 6) TO THE THEME PARKS CATEGORY FOR A TERM OF OFFICE TO EXPIRE ON JUNE 30, 2005; APPOINTING JEAN JAMES (DISTRICT 8) TO THE GENERAL COMMUNITY CATEGORY/SOUTHEAST SECTOR FOR A TERM OF OFFICE TO EXPIRE ON JUNE 30, 2006; AND REAPPOINTING JOHN BLOODSWORTH TO THE GENERAL COMMUNITY CATEGORY/SOUTHWEST SECTOR FOR A TERM OF OFFICE TO EXPIRE ON JUNE 30, 2006; TO THE CONVENTION AND VISITORS COMMISSION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Bart Huffman (District 8), Henry Feldman (District 8 and Mayor) and Michael Tease (District 2) are reappointed to the Hotel/Motel Association Category of the Convention and Visitors Commission for terms of office to expire on June 30, 2006.

SECTION 2. Marilyn DeSimone (District 9) is appointed to the Hotel/Motel Association Category of the Convention and Visitors Commission for a term of office to expire on June 30, 2005.

SECTION 3. Dr. Tom Cannon (District 6) is appointed to the San Antonio Area Tourism Council Category of the Convention and Visitors Commission for a term of office to expire on June 30, 2006.

SECTION 4. Daniel Decker (District 6) is appointed to the Theme Parks Category of the Convention and Visitors Commission for a term of office to expire on June 30, 2005.

SECTION 5. Jean James (District 9) is appointed to the General Community Category/Southeast Sector of the Convention and Visitors Commission for a term of office to expire on June 30, 2006.
