

## AN ORDINANCE 100362

**AUTHORIZING THE INTERIM CITY MANAGER, THE ASSISTANT CITY MANAGERS AND THE DIRECTOR OF HOUSING AND COMMUNITY DEVELOPMENT TO PROVIDE THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ("HUD") WITH ADDITIONAL INFORMATION REGARDING THE CITY'S REPAYMENT COMMITMENT FOR THE \$57,000,000.00 HUD 108 LOAN AND AMENDING THE CITY ACTION PLAN TO INCLUDE THE PROJECTS CONTAINED IN SAID LOAN APPLICATION.**

**WHEREAS**, Ordinance No. 99726, passed and approved on September 16, 2004, authorized the City's submission of a \$57,000,000.00 U.S. Department of Housing and Urban Development (HUD) 108 Loan Program Application to HUD; and

**WHEREAS**, it is the desire of the City Council to amend Ordinance No. 99726 and authorize the revision of the City's Repayment Commitment for the HUD 108 Loan Application to add a commitment, as recommended by HUD, to make or supplement annual debt payments from lawful revenues authorized by City Council if Community Development Block Grant (CDBG) funds are not available for repayment of the HUD 108 Loan; and

**WHEREAS**, Ordinance No. 99253, passed and approved on May 27, 2004, adopted the Fiscal Year 2004-2005 CDBG Consolidated Plan Annual Budget; and

**WHEREAS**, it is the desire of the City Council to amend Ordinance No. 99253 and authorize the amendment of the City's Action Plan to include the projects contained in the HUD 108 Loan Application; and

**WHEREAS**, it is City Council's intention to authorize staff to provide HUD with the additional information regarding the HUD 108 Loan and to make the appropriate amendments to be included in the loan application to reflect the City's repayment commitment and complete the HUD 108 Loan Application process; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The revision of the City's Repayment Commitment for the \$57,000,000.00 HUD 108 Loan Application to add a commitment to make or supplement annual debt payments from lawful revenues authorized by City Council if CDBG funds are not available for repayment of the HUD 108 Loan is hereby approved. Said revised Repayment Commitment is attached hereto and incorporated herein for all purposes as Attachment I. The Interim City Manager or in his

stead, either an Assistant City Manager or the Director of Housing and Community Development is hereby authorized to provide HUD with all additional information regarding said commitment. Ordinance No. 99726, passed and approved on September 16, 2004 is hereby authorized to be amended to reflect said revision.

**SECTION 2.** The City's Action Plan contained in the City's FY 2004-2005 CDBG Consolidated Plan is hereby authorized to be amended to include the projects contained in the HUD 108 Loan Application. Said amended Action Plan is attached hereto and incorporated herein for all purposes as Attachment II. Ordinance No. 99253, passed and approved on May 27, 2004 is hereby authorized to be amended to reflect the changes authorized herein.


**SECTION 3.** This Ordinance shall be effective on and after the 6<sup>th</sup> day of February, 2005.


