

AN ORDINANCE 100385

BESTOWING THE MEMORIAL DESIGNATION OF "ERNANI FALCONE MEMORIAL WAY" UPON MYSTIC PARK DRIVE.

* * * * *

WHEREAS, Ernani (Nani) Falcone was a vigorous and committed community representative for the neighborhoods and the citizens of the City of San Antonio; and

WHEREAS, Mayor Edward D. Garza and Councilman Julian Castro, District 7, requested that Mystic Park Drive be designated as a memorial in recognition and honor of the accomplishments of Mr. Falcone; and

WHEREAS, the City Council of the City of San Antonio wishes to acknowledge Mr. Falcone's Falcone's service to the City; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Mystic Park Drive is hereby given the memorial designation of "Ernani Falcone Way".

SECTION 2. Mystic Park shall retain its official name of "Mystic Park" and nothing within this ordinance shall be interpreted in any way as changing its name or causing a change of its name or official designation on any map or other document

SECTION 3. City staff are directed to erect proper signage, as shown in Attachment I, along the designated section of Mystic Park, showing the memorial designation


SECTION 4. Funds in the amount of \$784.14 are authorized to be appropriated in Cost Center 2303050028, General Ledger 5301010 entitled "Commodities M&R Material Building and Improvement, in Fund 29050000, entitled "Drainage Maintenance & Improvements".

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This ordinance shall be effective on February 13, 2005.


