

AN ORDINANCE 100398

ACCEPTING THE TEXAS STATE LIBRARY AND ARCHIVES COMMISSION FY 2005 LOAN STAR LIBRARIES GRANT AWARD IN THE AMOUNT OF \$87,838.00, TO BE USED TO REPLACE OVER EIGHTY (80) OUTDATED STAFF DESKTOP COMPUTER WORKSTATIONS THROUGHOUT THE SAN ANTONIO PUBLIC LIBRARY SYSTEM.

WHEREAS, the San Antonio Public Library recently implemented a new integrated library automation system, Innovative Interfaces Inc.; and

WHEREAS, existing technical services and circulation staff computers are not functioning at optimum capacity with the new system and as a result, materials are taking longer to process and customers are having to wait longer for assistance at the reference and circulation desks; and

WHEREAS, the Loan Star Libraries grant award program provides direct state aid for Texas public libraries and is available for Library use in addressing this problem; and

WHEREAS, grant funds will be used to replace over eighty outdated staff desktop computer workstations throughout the San Antonio Public Library system; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. The Interim City Manager, or his designee, is hereby authorized to accept the Texas State Library and Archives Commission FY 2005 Loan Star Libraries grant award in the amount of \$87,838.00, to be used to replace over eighty (80) outdated staff desktop computer workstations throughout the San Antonio Public Library System. The Interim City Manager, or his designee, is hereby authorized to execute any and all necessary contracts or other documents to effectuate that acceptance.

Section 2. Fund No. 26018000, Internal Order No. 104000000023, entitled "2004-2005 Lone Star Library Grant" has been established in accounting for said grant and is approved.

Section 3. The Director of Finance may, subject to concurrence by the Interim City Manager or the Interim City Manager's designee, correct allocation to specific internal order numbers, account numbers and fund numbers as necessary to carry out the purpose of this ordinance.

Section 4. This ordinance shall take effect immediately upon passage and approval by eight (8) affirmative votes.
