

AN ORDINANCE 100481

AUTHORIZING THE ESTABLISHMENT OF A DEDICATED REVENUE AND EXPENDITURE ACCOUNT TITLED "ANIMAL CARE FACILITY DONATION FUND" AND AUTHORIZING THE ACCEPTANCE OF ALL MONETARY DONATIONS FROM SOURCES THAT SUPPORT THE INITIATIVES FOR RESPONSIBLE PET OWNERSHIP AND SHELTER OPERATIONS WITHIN THE ANIMAL CARE DIVISION.

WHEREAS, the Animal Care Division has provided a service to the citizens of San Antonio by enforcing animal care regulations and operating a shelter; and

WHEREAS, in response to concerns expressed by the City Council and the general public, the Animal Care Division is enhancing its services; and

WHEREAS, through partnerships and collaborations, the Animal Care Division will be providing an off-site spay/neuter and adoption program, as well as an on-site treatment and a volunteer program, in order to promote the welfare of animals in the facility; and

WHEREAS, there has been an interest expressed within the community to donate funds to the Animal Care Facility in order to support such strategic efforts; and

WHEREAS, the donations will be utilized to sponsor animals for spaying or neutering, to complete payment of adoption fees, to provide medications for the treatment of sick or injured animals, for educational efforts, to support foster care, to purchase pet supplies, to purchase any other item the donor requests the funds be targeted for, and for any other purpose that will enhance Animal Care Services; and

WHEREAS, it is now necessary to authorize the establishment of a dedicated revenue and expenditure account for the acceptance of donations to begin in the current fiscal year FY04/05; and

WHEREAS, the revenues will be deposited in said account and annual appropriations made from it will be addressed during the City's annual budget development process; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The establishment of a dedicated revenue and expenditure account entitled, "Animal Care Facility Donation Fund" is hereby authorized to be used to sponsor animals for spaying or neutering, to complete payment of adoption fees, to provide medications for the

treatment of sick injured animals, for educational efforts, to support foster care, to purchase pet supplies, to purchase any other item the donor requests the funds be targeted for, and for any other purpose that will enhance Animal Care Services. The acceptance of donations to be deposited in said account shall begin during the current Fiscal Year 2004/2005.


SECTION 2. Funds are authorized to be deposited in Fund 29636000, entitled "Animal Care Facility Donation Fund", Functional Area 360020000006, Internal Order Number 236000000147, General Ledger 4502210 entitled "Contribution".

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the Interim City Manager or the Interim City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. The Animal Care Division is hereby authorized to accept all monetary donations from the public for deposit to said account. Annual appropriations made from this account shall be addressed during the City of San Antonio's annual budget development process.

SECTION 5. This ordinance shall be effective on and after March 6, 2005.


