

AN ORDINANCE 100459

AUTHORIZING PAYMENT IN THE AMOUNT OF \$13,703.00 TO K. M. NG & ASSOCIATES, INC. (SBE/DBE/MBE) FOR ON-CALL CIVIL ENGINEERING SERVICES, PASSED AND APPROVED ON AUGUST 7, 2003, BY ORDINANCE NO. 97945, IN CONNECTION WITH THE SOUTHSIDE LIONS PARK POOL DRAIN LINE RELOCATION COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROJECT, LOCATED IN COUNCIL DISTRICT 3; AUTHORIZING \$3,000.00 FOR ENGINEERING CONTINGENCY EXPENSES; AUTHORIZING \$1,000.00 FOR BID ADVERTISING AND PRINTING EXPENSES; AUTHORIZING \$3,000.00 FOR MANDATORY PROJECT FEES, FOR A TOTAL AMOUNT OF \$20,703.00; REVISING THE BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.

WHEREAS, the City Council has approved the Southside Lions Park Pool Drain Line Relocation Project as part of the Community Development Block Grant (CDBG) Program; and

WHEREAS, by Ordinance No. 97945, August 7, 2003, City Council authorized an on-call civil engineering services contract with K. M. Ng & Associates, Inc. for civil engineering services; and

WHEREAS, in connection with said Project, there is a need for K. M. Ng & Associates, Inc., a civil engineering firm, to provide engineering services in connection with relocation of a pool drain line at the Southside Lions Community Center pool from its current connection to a storm sewer to a new connection to an existing sanitary sewer line; and

WHEREAS, it is the City Council's intention to authorize the appropriation, allocation and payment of Community Development Block Grant (CDBG) funds for civil engineering services provided by K. M. Ng & Associates, Inc.; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The appropriation and allocation of Community Development Block Grant (CDBG) funds in the amount of \$20,703.00 for civil engineering services rendered in connection with Southside Lions Park Pool Drain Line Relocation Community Development Block Grant (CDBG) Project is hereby approved.

SECTION 2. The sum of \$13,703.00, representing civil engineering services, is hereby authorized to be paid to K. M. Ng & Associates, Inc. in connection with Southside Lions Park Pool Drain Line Relocation Community Development Block Grant (CDBG) Project in accordance with the on-call professional services agreement authorized in Ordinance No. 97945, passed and approved August 7, 2003.

SECTION 3. The CDBG 30th Year Program budget, Fund No. 28030000, is authorized to be revised as set out in the detailed budget affixed hereto and incorporated herein for all purposes as Attachment I.

SECTION 4. The amount of \$13,703.00 is hereby authorized to be encumbered and made payable to K. M. Ng & Associates, Inc. from Fund No. 28030000, WBS #26-00429-01-02.

SECTION 5. Encumbrances are to be authorized and made payable in Fund No. 28030000, project 26-00426, entitled "Southside Lions Park Pool Drain Line Relocation Project" as follows:

- \$ 3,000.00 for miscellaneous engineering contingency expenses in WBS #26-00429-01-03-01;
- \$ 1,000.00 for bid advertising and printing from WBS #26-00429-05-01; and
- \$ 3,000.00 for mandatory project fees from WBS #26-00429-01-02-02.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the Interim City Manager or Interim City Manager's designee, correct allocations to specific SAP Fund numbers as necessary to carry out the purpose of this Ordinance.


SECTION 7. This ordinance shall become effective on and after the sixth (6th) day of March, 2005.
