

AN ORDINANCE 100505

CLOSING, VACATING AND ABANDONING TWO 14 FOOT-WIDE ALLEYS LOCATED DIRECTLY NORTH OF FLORIDA STREET BETWEEN S. SAINT MARY'S STREET AND S. PRESA STREETS WITHIN NCB 2992, IN COUNCIL DISTRICT 1, FOR THE DEVELOPMENT AND CONSTRUCTION OF FIRE STATION NO. 7, AS REQUESTED BY CITY OF SAN ANTONIO FIRE DEPARTMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City hereby closes, vacates, and abandons in their entirety the following two alleys:

- (a) The alley extending north from Florida Street into New City Block 2992 bounded on the west by lot 5 and on the east by lots 7 and 8.
- (b) The alley extending north from Florida Street into New City Block 2992 bounded on the west by lots 2 and 3 and on the east by lot 4.

SECTION 2. The City Manager or his designee is authorized and directed to execute and deliver all documents and to do all other things necessary or convenient to reflect this closure, abandonment, and vacation.

SECTION 3. This ordinance shall become effective March 13, 2005, unless it receives the eight votes requisite to immediate effectiveness under City Code of San Antonio § 1-15, in which case it shall be effective immediately.
