

AN ORDINANCE 100504

AUTHORIZING THE INTERIM CITY MANAGER OR HIS DESIGNEE TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH ARCUS, L.L.C. FOR AN ESTIMATED MONTHLY AMOUNT OF \$35,000, WITH A PROJECTED TOTAL OF \$140,000 TO PROVIDE THE CITY OF SAN ANTONIO WITH AN INTERIM CHIEF INFORMATION OFFICER.

WHEREAS, the City invests millions of dollars annually in technology-related expenses; and comprehensively incorporating these technology enhancements into the City's business and operational requirements while creating an accessible environment for the citizens or users would assure the success of these investments; and

WHEREAS, the City wishes to begin the process of creating a Chief Information Officer position as a member of the City's Management Team to develop a comprehensive approach to ongoing technology implementations and strategically incorporating those enhancements; and

WHEREAS, the City of San Antonio wishes to fill the position of Chief Information Officer on an interim basis with technical personnel provided by an executive recruitment company; and

WHEREAS, the City wishes to execute a contract with Arcus, L.L.C. to provide an Interim Chief Financial Officer for the City of San Antonio;

WHEREAS, technical personnel provided by Arcus, L.L.C. began work as Interim CIO on March 2, 2005 and it is now necessary to ratify the provision of those services; **NOW, THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1: The City Council authorizes the Interim City Manager, or his designee, to execute a contract with Arcus, L.L.C. for an estimated monthly amount of \$35,000, for a projected total of \$140,000.00 to provide an Interim Chief Information Officer. A copy of said contract, in substantially final form, is attached hereto as Exhibit A. The terms and conditions of said contract are hereby approved. The Interim City Manager or the Interim City Manager's designee is authorized to execute the final contract, in

substantially the form attached hereto as Exhibit A, for a period not to exceed forty-five days from the effective date of this ordinance. If for any reason the final documents are not executed within forty-five days from the effective date of this ordinance, or if they cannot be executed in substantially the form attached, the authorization of this contract and the execution thereof will be subject to subsequent City Council approval. Any services already provided in connection with this contract are hereby ratified

SECTION 2: Funds in the amount of \$100,000.00 are encumbered in Fund 11001000 entitled "General Fund", Cost Center 8009510001, General Ledger 5201040 entitled "Fees to Professional Contractors." Payment is authorized payable to Arcus, L.L.C.

SECTION 3: Funds in the amount of \$40,000.00 are encumbered in Fund 11001000 entitled "General Fund", Cost Center 501010001, General Ledger 5201040 entitled "Fees to Professional Contractors." Payment is authorized payable to Arcus, L.L.C.

SECTION 4: The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5: This Ordinance shall become effective immediately upon the passage by eight (8) votes of the City Council and, if passed upon fewer than eight (8) votes, then after the tenth (10th) day after passage hereof.


