

AN ORDINANCE 100577

GRANTING A LICENSE AGREEMENT TO VILLAJE DEL RIO, LTD., TO BUILD AND MAINTAIN OVERHEAD PASSAGeways AND BALCONIES EXTENDING OVER PUBLIC RIGHTS-OF-WAY IN A REDEVELOPED PROPERTY SITUATED NEAR THE INTERSECTION OF AVENUE B AND ROY SMITH STREET IN COUNCIL DISTRICT 1; AND WAIVING THE ASSOCIATED FEE UNDER THE CITY'S INCENTIVE SCORECARD PROGRAM

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City hereby authorizes and directs the City Manager, Interim City Manager, or designee to execute and deliver the License Agreement attached as **Exhibit A** with Villaje del Rio, Ltd. relating to City project number 1185.

SECTION 2. The fee established for this license agreement of \$11,336.00 is waived in accordance with the 100% reduction provided by the City's Incentive Scorecard Program

SECTION 3. This ordinance shall become effective April 3, 2005 unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it shall be effective immediately.


