AN ORDINANCE AUTHORIZING THE INTERIM CITY MANAGER OR HIS DESIGNEE TO EXECUTE AN AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION FOR CONSTRUCTION/RECONSTRUCTION, MAINTENANCE, AND OPERATION OF ADDITIONAL AESTHETIC IMPROVEMENTS IN CONNECTION WITH THE HOUSTON AND COMMERCE UNDERPASS (HOUSTON AND COMMERCE AT I.H. 37) ENHANCEMENTS PROJECT, LOCATED IN COUNCIL DISTRICTS 1 AND 2.

WHEREAS, the City of San Antonio has previously entered into a Multiple Use Agreement with the Texas Department of Transportation dated June 11, 1999, for the construction, maintenance and operation of public pedestrian walkways, pedestrian crosswalks, landscaping, irrigation systems, lighting, and other improvements on the highway right-of-way located on I.H. 37 right-of-way at Commerce Street; and

WHEREAS, the City of San Antonio now desires to construct/reconstruct, maintain, and operate additional aesthetic improvements on I.H. 37 at Commerce Street and I.H. 37 at Houston Street, including public pedestrian walkways, pedestrian crosswalks, landscaping, irrigation systems, lighting, art and other aesthetic improvements; **NOW THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The Interim City Manager or his designee is authorized to execute a "Multiple Use Agreement for Aesthetic Improvements on I.H. 37 at Commerce Street and I.H. 37 at E. Houston Street" with the Texas Department of Transportation for construction/reconstruction, maintenance, and operation of additional aesthetic improvements in connection with the Houston and Commerce Underpass (Houston and Commerce at I.H. 37) Enhancement Project, located in Council Districts 1 and 2, which agreement is hereto appended in substantial form with associated exhibits as Attachment A.

**SECTION 2.** This ordinance shall take effect on the 10th day of April, 2005.


