AN ORDINANCE **101179**

SETTING THE FOLLOWING DATES, TIMES, AND LOCATIONS FOR THE FIRST AND SECOND PUBLIC HEARINGS ON THE PROPOSED BUDGET FOR FY 2005-2006: TUESDAY, AUGUST 23, 2005, 6:00 P.M., AND TUESDAY, SEPTEMBER 6, 2005, 6:00 P.M., IN THE CITY COUNCIL CHAMBERS, 103 MAIN PLAZA; AND SETTING THE FOLLOWING DATES, TIMES AND LOCATIONS FOR THE FIRST AND SECOND PUBLIC HEARINGS ON THE PROPOSED TAX RATE FOR THE TAX YEAR BEGINNING JANUARY 1, 2005 AND ENDING DECEMBER 31, 2005: THURSDAY, SEPTEMBER 1, 2005, 6:00 P.M., AND THURSDAY, SEPTEMBER 8, 2005, 6:00 P.M., IN THE CITY COUNCIL CHAMBERS, 103 MAIN PLAZA.

WHEREAS, a public hearing on the proposed annual budget of the City of San Antonio is required by Section 102.006 of the Texas Local Government Code and Section 82 of the City Charter; and

WHEREAS, two public hearings on the proposed annual tax rate of the City of San Antonio are required by Chapter 26 of the Texas Tax Code if it exceeds the effective rate; and

WHEREAS, the City Council now wishes to officially set the dates, times, and locations for these public hearings and provide for public notice, **NOW, THEREFORE;**

BE IT ORDAINED BY THE CITY OF SAN ANTONIO:

SECTION 1. A public hearing on the Fiscal Year 2005-2006 Proposed Budget is hereby scheduled for Tuesday, August 23, 2005, from 6:00 P.M. until completion, in the City Council Chambers, 103 Main Plaza. A second public hearing is scheduled for Tuesday, September 6, 2005, from 6:00 until completion, in the City Council Chambers, 103 Main Plaza.

SECTION 2. A public hearing on the Proposed Tax Rate for the tax year beginning January 1, 2005 and ending December 31, 2005 is hereby scheduled for Thursday, September 1, 2005, from 6:00 P.M. until completion, in the City Council Chambers, 103 Main Plaza. A second public hearing is scheduled for Thursday, September 8, 2005, from 6:00 until completion, in the City Council Chambers, 103 Main Plaza.

SECTION 3. City staff is hereby directed to publish notice of these hearings, as provided by law.

SECTION 4. This ordinance shall take effect on the tenth day from the passage hereof.


