**EXPRESSING SUPPORT FOR THE CONSOLIDATION OF
THE ACTIVITIES AND OPERATIONS OF THE SAN
ANTONIO HOUSING AUTHORITY AND THE HOUSING
AUTHORITY OF BEXAR COUNTY.**

WHEREAS, the provision of safe, decent and affordable housing for low-income families is of critical importance to the entire metropolitan area of the City of San Antonio and Bexar County; and

WHEREAS, currently, there exist two housing authorities, namely, the San Antonio Housing Authority (SAHA) and the Housing Authority of Bexar County (HABC) that provide many of the same services; and

WHEREAS, the City of San Antonio/Bexar County Citizens Commission on Service Integration and the Bexar County Commissioners Court recommend functional consolidation of SAHA and HABC to prevent redundant administrative structures; and

WHEREAS, the Bexar County Commissioners Court supports the functional consolidation of SAHA and HABC, as evidenced by a resolution passed and approved by the Bexar County Commissioners Court on July 26, 2005; and

WHEREAS, on August 17, 2005, the City Council Urban Affairs Committee met to discuss the proposed consolidation of SAHA and HABC and recommended a task force be created; and

WHEREAS, the City of San Antonio City Council Governance Committee supports examining the possibility of the proposed consolidation of the functions of SAHA and HABC; and

WHEREAS, it is the desire of the City Council to express support for this consolidation; **NOW THEREFORE:**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council of the City of San Antonio hereby expresses its support for the consolidation of the activities and operations of the San Antonio Housing Authority and the Housing Authority of Bexar County.

SECTION 2. This resolution shall become effective on and after the 28th day of August, 2005.
