

AN ORDINANCE      101246

**AUTHORIZING THE ACCEPTANCE OF \$6,500.00 FROM SMITHKLINE BEECHAM CORPORATION, D/B/A GLAXOSMITHKLINE (GSK) TO AUGMENT THE PARTICIPATION OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT IN A VACCINE STUDY FOR THE PREVENTION OF HUMAN PAPILOMAVIRUS (HPV) INFECTION IN WOMEN; AUTHORIZING THE EXECUTION OF AN AGREEMENT; AND REVISING THE PROJECT BUDGET.**

**WHEREAS**, GlaxoSmithKline (GSK), one of the world's leading pharmaceutical and healthcare companies, offered a clinical study agreement to the San Antonio Metropolitan Health District (SAMHD) for the period January 1, 2004 through December 31, 2005; and

**WHEREAS**, Ordinance No. 98588, passed and approved on December 18, 2003, authorized the execution of said agreement with GSK that provides up to \$50,868.00 for the SAMHD to participate in a vaccine study for the prevention of human papillomavirus (HPV) cervical infection in adolescent and young adult women; and

**WHEREAS**, through an amendment to the clinical study agreement, GSK has now offered an additional \$6,500.00 to augment SAMHD's participation in the ongoing HPV vaccine study; and

**WHEREAS**, the SAMHD desires to continue participation in this ongoing study and to provide participants with vaccines free of charge; and

**WHEREAS**, it is now necessary to authorize the acceptance and execution of this amendment with GSK and revise the project budget; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager, or his designee, is hereby authorized to accept and execute an amendment to the Clinical Study Agreement, Protocol 580299/007, with GlaxoSmithKline during the period January 1, 2004 through December 31, 2005, which will provide an additional \$6,500.00 for the San Antonio Metropolitan Health District to continue participation in a vaccine study for the prevention of human papillomavirus (HPV) cervical infection in adolescent and young adult women. A copy of the amendment to the clinical study agreement, in substantially correct form, is attached hereto and incorporated herein for all purposes as Attachment I.

**SECTION 2.** Fund No. 26012000, Funds Center 3607170000, Internal Order 136000000040, has been designated for use in accounting for the fiscal transactions of this project.

**SECTION 3.** The additional sum of \$6,500.00 is hereby appropriated in GL No. 4402100 of the above-designated fund and the budget set out in Attachment II is approved and adopted for entry on the City books.

**SECTION 4.** The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific fund numbers, internal order numbers and SAP GL numbers as necessary to carry out the purpose of this ordinance

**SECTION 5.** Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

**SECTION 6.** This ordinance shall be effective on and after August 28, 2005.
