

AN ORDINANCE **101263**

AUTHORIZING A 10 YEAR LICENSE AGREEMENT WITH THE MIRACLE LEAGUE OF SAN ANTONIO TO USE 3.67 ACRES OF CITY OWNED PROPERTY FOR THE PURPOSE OF DEVELOPING AND MAINTAINING YOUTH SPORTS FIELDS FOR CHILDREN OF ALL ABILITIES.

WHEREAS, athletic organizations request to develop and utilize City property through long-term lease arrangements in order to provide practice and game fields for their league play and in exchange, the organizations provide venues for youth sports and maintain the specified park areas at their own expense; and

WHEREAS, the Miracle League of San Antonio has requested the use of 3.67 acres of fields at the recently acquired Levi Strauss property adjacent to the Wolff Baseball Stadium; and

WHEREAS, the Miracle League of San Antonio will use the 3.67 acres of fields for the purpose of developing all weather surface football, soccer and track fields for use by individuals with physical disabilities; and

WHEREAS, this license agreement is consistent with the master plan for the property which includes a sports field buffer along the eastern boundary of this City property; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. The City Manager, or his designee, is hereby authorized to execute the 10 year License Agreement with the Miracle League of San Antonio for the use of 3.67 acres of city owned property for the purpose of developing and maintaining youth sports fields for individuals with physical disabilities. A copy of the license agreement, in substantially final form, is affixed hereto and incorporated herein for all purposes as Attachment I.

Section 2. This ordinance shall become effective on and after August 28, 2005.
