

AN ORDINANCE      **101166**

**AUTHORIZING THE ACCEPTANCE OF  
ADDITIONAL GRANT FUNDS IN THE AMOUNT OF  
\$5,378.00 FROM THE TEXAS STATE LIBRARY AND  
ARCHIVES COMMISSION TO SUPPORT  
PERSONNEL COSTS FOR TEMPORARY STAFF  
AND OPERATING EXPENSES DURING THE  
REMAINDER OF THE CONTRACT YEAR.**

**WHEREAS,** The City of San Antonio is a Major Resource Center for the Alamo Area Library System, providing services to Bexar County and 20 other contiguous counties; and

**WHEREAS,** Since 1972, the City has provided this service and has accepted federal grant funds through the Texas State Library and Archives Commission in support of this service; and

**WHEREAS,** Ordinance No. 99759, which was passed and approved by City Council on September 23, 2004, authorized the acceptance of grant funding in the amount of \$258,079.00 from the Texas State Library and Archives Commission; and

**WHEREAS,** the Texas State Library and Archives Commission has now offered additional grant funds in the amount of \$5,378.00 to support personnel costs for temporary staff for the remainder of the year and to cover unanticipated operating expenses; and

**WHEREAS,** it is now necessary for the City Council to authorize the acceptance of this additional grant funding; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**Section 1.** The Interim City Manager, or his designee, is hereby authorized to accept additional grant funds from the Texas State Library and Archives Commission in the amount of \$5,378.00 to support personnel costs for temporary staff and operating expenses during the remainder of the contract year.

**Section 2.** Fund No. 26018000, Internal Order No. 104000000021 entitled "Interlibrary Loan Services Grant" has been designated for use in accounting for this grant.

**Section 3.** The sum of \$5,378.00 in additional funding is approved and hereby appropriated in said fund as set out in the detailed budget revision affixed hereto and incorporated herein for all purposes as Attachment A.

**Section 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific SAP Fund Numbers and Internal orders as necessary to carry out the purpose of this Ordinance.

**Section 5.** This ordinance shall be effective on and after August 21, 2005.


